## **10. PUBLIC HEARINGS**

- 10.1\*** PUBLIC HEARING - BUNYA BUNYA TREE REMOVAL (APPEAL) - 1080 2ND ST - TR22-062 (CONTINUED FROM AUGUST 24, 2023)

BACKGROUND: On March 3, 2023, a Tree Permit requesting to

remove an approximately 125-foot Bunya Bunya Tree was denied by the Director of Planning and Economic Development. The Salvation Army Residences, Inc. has appealed that decision to the Planning Commission. The tree is located at 1080 2nd Street, between the community garden and the sidewalk along the 2nd Street frontage. The project is exempt from the California Environmental Quality Act.

Ethel Rogers commented on the danger of the tree.
