RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AMENDING THE TRANSACTION AND USE TAX IMPLEMENTATION PLAN FOR GANG PREVENTION/INTERVENTION SERVICES

WHEREAS, on August 3, 2004, the Council adopted Ordinance No. 3680 adding Chapter 3-26, including sections 3-26.120 (A-H), to the Santa Rosa City Code, which imposes a special transactions and use tax (Special Tax), the revenues of which may only be utilized for specified Police and Fire purposes and uses and gang prevention and youth programs as set forth in Chapter 3-26; and

WHEREAS, in the City's November 2004 election, the Special Tax, identified and known as ballot Measure O, was approved by more than two thirds of the voters voting thereon and the election result was certified on December 7, 2004; and

WHEREAS, in accordance with Section 3-26.120(F) of the City Code, the Council approved a Transaction and Use Tax Implementation Plan (the Plan) on September 21, 2004, by Resolution No. 26069; and

WHEREAS, the Plan sets forth the authorized uses, purposes and programs to be funded by the Special Tax's revenues along with the estimated amounts and dates of such funding; and

WHEREAS, the Council, in accordance with section 3-26.120(F) of the City Code, thereafter approved amendments to the Plan on February 1, 2005, by Resolution No. 26184; on February 28, 2006, by Resolution No. 26506; on June 15, 2006, by Resolution No. 26585; on August 15, 2006, by Resolution No. 26636; on September 11, 2007, by Resolution No. 26930; on April 8, 2008, by Resolution No. 27070; on June 19, 2008, by Resolution No. 27139; on September 23, 2008, by Resolution No. 27206; on June 19, 2009, by Resolution No. 27413; and on June 15, 2010 by Resolution No. 27649; on June 15, 2011 by Resolution No. 27910; and

WHEREAS, the utilization of this proposed change would constitute a change to the Plan and would require the approval of six Council members.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa amends the Transaction and Use Tax Implementation Plan, which, as so amended, is attached, marked Exhibit A, and made a part of this resolution.

BE IT FURTHER RESOLVED that the Council of the City of Santa Rosa amends the City's Classification and Salary Plan in GL 020400 to include a limited term 1.0 FTE Senior Administrative Assistant for January 1 – June 30, 2014 to be funded by the Measure O Gang Prevention fund balance.

BE IT FURTHER RESOLVED that the Council of the City of Santa Rosa approves an increase in appropriations in GL 020400-20 in the amount of \$125,000 for the MGPTF Strategic Plan Implementation and in GL 350610-21 in the amount of \$250,000 for the Responsive Grant Program, each to be funded by the Measure O Gang Prevention fund balance.
