WHEREAS, on April 19, 2017, the Second Amendment to the Agreement was approved by the City Manager for a one-year extension with no increase to unit price and \$100,000 increase in compensation; and

WHEREAS, on April 17, 2018, the Third Amendment to the Agreement was approved by Council for a second one-year extension with no increase to unit price and \$100,000 increase in compensation; and

WHEREAS, on April 4, 2019, the Fourth Amendment to the Agreement was approved by the City Manager for a third one-year extension with no increase to unit price and \$100,000 and increase in compensation; and

WHEREAS, on December 3, 2019, the Fifth Amendment to the Agreement was approved by Council increasing compensation by \$40,000 for the term ending April 20, 2020; and
