12. REPORT ITEMS

12.1 REPORT – PROPOSED PARK NAMING RECOMMENDATION FINALI NEIGHBORHOOD PARK

BACKGROUND: The Board of Community Services has solicited names for the Neighborhood Park site located at Jennings and Range Avenues. On May 22, 2013, the Board of Community Services adopted its recommendation to name the new park Finali Neighborhood Park, in honor of Fiorino Richard Finali, whose family lived and farmed the land where the park is located for four generations.

RECOMMENDATION: It is recommended by the Board of Community Services and the Recreation and Parks Department that the Council, by resolution, name the park site located at Jennings Avenue and Range Avenue, Finali Neighborhood Park.

Jennifer Phillips, Assistant City Manager, provided the staff report and responded to questions from Council Members.

Tina Finali spoke of the dedication her family had to the property and thanked the Council for the honor.

MOVED by Council Member Olivares and seconded by Council Member Wysocky to waive reading of the text and adopt:

RESOLUTION NO. <u>28311</u> ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA NAMING THE FINALI NEIGHBORHOOD PARK

Council Member Combs suggested a friendly amendment to the resolution language to include the mother's name, Susan Finali. The friendly amendment was accepted by the maker and seconder of the motion.

Following Council discussion, the motion **CARRIED** carried 6-0-1 (Vice Mayor Carlstrom absent) to adopt as amended.

13. PUBLIC HEARINGS

13.1 PUBLIC HEARING – ANNUAL WEED ABATEMENT PROGRAM

BACKGROUND: The Santa Rosa City Code requires a public hearing to hear objections to the cost of weeds and/or rubbish abatement. The City Council grants or overrules such protests. The City Council, by resolution, may confirm the itemized report of the costs of abatement. The City Council authorizes the Santa Rosa Fire Department, County Auditor and Tax Collector to enact a special assessment as a lien upon respective parcels subject to the weed and rubbish abatement program.

RECOMMENDATION: It is recommended by the Fire Department that the Council, by resolution, ratify and confirm the itemized report of the Fire Department of the cost of weed and rubbish abatement as provided for in Sections 9-08.020, 9-08-080, and 9-08.090, Chapter 9-08 of the Santa Rosa City Code.

Toby Rey, Fire Inspector, provided the staff report.

PUBLIC HEARING

Mayor Bartley opened the public hearing.

Peter Tscherneff spoke in support of the Fire Department and cacti as living fences.

Seeing no one else wishing to speak, Mayor Bartley closed the public hearing.

MOVED by Council Member Olivares, seconded by Council Member Swinth, and **CARRIED** 6-0-1 (Vice Mayor Carlstrom absent) to waive reading of the text and adopt:

RESOLUTION NO. <u>28312</u> ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA CONFIRMING THE ITEMIZED REPORT OF THE SANTA ROSA FIRE DEPARTMENT OF THE COST OF REMOVING WEEDS AND/OR RUBBISH FROM, UPON, OR IN FRONT OF CERTAIN LOTS OR PARCELS OF LAND WITHIN THE CITY OF SANTA ROSA

12.2 REPORT – REAUTHORIZATION TO ISSUE 2013 PENSION OBLIGATION REFUNDING BONDS (FEDERALLY TAXABLE) AND TO REFUND OUTSTANDING PENSION OBLIGATION REFUNDING BONDS, SERIES 2003A AND 2003B

BACKGROUND: On May 21, 2013, the Council approved Resolution No. 28283, which authorized the refunding of outstanding 2003 Pension Obligation Refunding Bonds, Series A (Variable Rate) and Series B (Fixed Rate), and approved the issuance of 2013 Pension Obligation Refunding Bonds (Federally Taxable) in a principal amount of not-to-exceed \$35 million. The refinancing includes \$4 million principal pay down of the Pension Obligation Bonds (POBs) consisting of one-time Property Tax Administration Fee settlement, Enterprise, Internal Services and Debt Services Funds.

The 2003 POBs Series A (Variable Rate) require an Irrevocable Letter of Credit (LOC) issued by a bank as security for investors. Complying with the LOC requirement has become a challenge due to financial uncertainty associated with California governments. The proposed refinancing would reduce the City exposure to the risks of the availability of LOC in the future, rising LOC costs due to fewer LOC banks on the market and rising short term rates.

The average interest rate on the outstanding 2003 POBs Series B (Fixed Rate) is 5.18%. Based on the market conditions in mid-May 2013, the average interest rate was estimated at 3.40%.

Since the Council approved the refinancing of the Pension Obligations Bonds on May 21, 2013, market conditions have changed and interest rates have risen. The Treasury market is exhibiting volatility as it reacts to recently released economic data. Treasury yields have faced upward pressure as market participants consider a potential shift to a higher interest rate environment. Based on the current market conditions, the projected average interest rate would exceed the 4% limit approved by Resolution No. 28283.

A detailed explanation of the current market conditions will be provided by staff, financial advisor and bond underwriter.

RECOMMENDATION: It is recommended by the Finance Department that the Council, by resolution, (1) reauthorize the refunding of outstanding 2003 Pension Obligation Refunding Bonds, Series A (Variable Rate) and Series B (Fixed Rate); (2) reauthorize an appropriation of City funds to the prepayment of the 2003 Pension Obligation Bonds in the amount of \$4 million from the one-time Property Tax Administration Fee settlement, Enterprise, Internal Services and Debt Services Funds; (3) reauthorize the issuance of 2013 Pension Obligation Refunding Bonds (Federally Taxable) in a principal amount of not-to-exceed \$35 million; (4) reauthorize a Preliminary Official Statement; and (5) reapprove and reauthorize the execution of related documents by the City Manager, Chief Financial Officer or their respective delegates and actions with respect thereto.

Lawrence Chiu, Chief Financial Officer, provided the staff report and responded to questions from Council Members.

Peter Tscherneff spoke regarding various topics.

MOVED by Council Member Combs and seconded by Council Member Olivares to waive reading of the text and adopt:

12.4 REPORT - ORDINANCE INTRODUCTION – SONOMA CLEAN POWER – COMMUNITY CHOICE AGGREGATION (Continued from the July 9, 2013, Regular Meeting)

BACKGROUND: On July 9, 2013, the City Council adopted, by unanimous vote, a resolution requesting that the Sonoma Clean Power Authority act as Community Choice Aggregator on behalf of the City and implement the Sonoma Clean Power Community Choice Aggregation program within the City Of Santa Rosa provided that certain changes are made in writing to the Joint Powers Agreement and Draft Implementation Plan as outlined and amended in the draft resolution. The Council further directed staff to place on the July 16, 2013, agenda a final resolution for adoption and an ordinance for introduction authorizing the implementation of a Community Choice Aggregation Program.

RECOMMENDATION: It is recommended by the City Manager's Office that the Council: (1) adopt a final resolution requesting that the Sonoma Clean Power Authority act as Community Choice Aggregator on behalf of the City of Santa Rosa and Implement the Sonoma Clean Power Community Choice Aggregation Program within the City of Santa Rosa; and (2) introduce an ordinance of the City of Santa Rosa authorizing the implementation of a Community Choice Aggregation Program.

City Manager Kathleen Millison provided the staff report and responded to questions from Council Members.

MOVED by Council Member Swinth and seconded by Council Member Ours to waive reading of the text and adopt:
