RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA REQUESTING THE ALLOCATION OF FISCAL YEAR 2016/2017 TRANSPORTATION DEVELOPMENT ACT, ARTICLE III - PEDESTRIAN/BICYCLE PROJECT FUNDING FROM THE METROPOLITAN TRANSPORTATION COMMISSION

WHEREAS, Article III of the Transportation Development Act (TDA), Public Utilities Code (PUC) Section 99200 <u>et seq.</u>, authorizes the submission of claims to a regional transportation planning agency for the funding of projects exclusively for the benefit and/or use of pedestrians and bicyclists; and

WHEREAS, the Metropolitan Transportation Commission (MTC), as the regional transportation planning agency for the San Francisco Bay region, has adopted MTC Resolution No. 4108, entitled "Transportation Development Act, Article III, Pedestrian/Bicycle Projects," which delineates procedures and criteria for submission of requests for the allocation of "TDA Article III" funding; and

WHEREAS, MTC Resolution No. 4108 requires that requests for the allocation of TDA Article III funding be submitted as part of a single, countywide coordinated claim from each county in the San Francisco Bay region; and

WHEREAS, the City of Santa Rosa desires to submit a request to MTC for the allocation of TDA Article III funds to support the construction of Montecito Boulevard Bike Enhancements, Citywide Green Bike Lane Transition Enhancements and Citywide Pedestrian Enhancements more particularly described in the Project Application Forms, attached here to as Exhibit B, which are for the exclusive benefit and/or use of pedestrians and/or bicyclists; and

WHEREAS, on January 21, 2016, the City's Bicycle and Pedestrian Advisory Board (BPAB) by motion supported the staff recommendation for the allocation of FY 2016/17 TDA Article III funds to the Montecito Boulevard Bike Enhancements, Citywide Green Bike Lane Transition Enhancements and Citywide Pedestrian Enhancements.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa declares it is eligible to request an allocation of TDA Article III funds pursuant to Section 99234 of the Public Utilities Code.

BE IT FURTHER RESOLVED by the Council that:

- the City of Santa Rosa attests to the accuracy of and approves the statements in Exhibit A attached hereto; and
- there is no pending or threatened litigation that might adversely affect the projects
 described in Exhibit B attached hereto, or that might impair the ability of the City of
 Santa Rosa to carry out the project.

BE IT FURTHER RESOLVED that the Montecito Boulevard Bike Enhancements, Citywide Green Bike Lane Transition Enhancements and Citywide Pedestrian Enhancements has been reviewed by the City of Santa Rosa Bicycle and Pedestrian Advisory Board (BPAB).

BE IT FURTHER RESOLVED by the Council that a certified copy of this resolution and its attachments, and any accompanying supporting materials shall be forwarded to the Sonoma County Transportation Authority (SCTA) of Sonoma County for submission to MTC as part of the countywide coordinated TDA Article III claim.

BE IT FURTHER RESOLVED that the Council authorizes the Director of Transportation and Public Works to file an application and all documentation necessary with MTC and SCTA to request and execute the allocation of Article III funds through the TDA Program.

BE IT FURTHER RESOLVED that the Council authorizes the Chief Financial Officer to increase appropriations in JL Key 17560 – Montecito Boulevard Bike Enhancements by \$40,000 to this project.

BE IT FURTHER RESOLVED that the Council authorizes the Chief Financial Officer to increase appropriations in JL Key 17561 – Citywide Green Bike Lane Transition Enhancements by \$78,000 to this project.

BE IT FURTHER RESOLVED that the Council authorizes the Chief Financial Officer to increase appropriations in JL Key 17537 – Citywide Pedestrian Enhancements by \$47,000 to this project.
