6.1 PRESENTATION - REIMAGINING DOWNTOWN: PEDESTRIAN FRIENDLY STREETS SURVEY RESULTS

**6.2 MOTION - COMMUNITY IMPROVEMENT GRANTS**

The Community Advisory Board (CAB) reviews and approves the 2025 Community Improvement Grant Applications. The Board shall award grants to the applicants whose projects best meet the criteria. There are four grants that have been submitted for the June-July 2025 period, totaling \$9,922. The current balance is \$38,374.70; if all grants are awarded the remainder balance for the current fiscal year will be \$28,452.70.
