SUBJECT: CONTRACT AWARD – ANNUAL SLURRY SEAL 2020

AGENDA ACTION: MOTION

RECOMMENDATION

It is recommended by the Transportation and Public Works Department that the Council, by motion, award Contract No. C02318, Annual Slurry Seal 2020, in the amount of \$499,600.00 to the lowest responsible bidder, DRYCO Construction, Inc., of Fremont, California, approve a 10% contract contingency, and authorize a total contract amount of \$549,560.00, effective July 1, 2020.

EXECUTIVE SUMMARY

This motion will award a contract to DRYCO Construction, Inc., of Fremont, California, approve a 10% contract contingency and authorize a total contract amount of \$499,600.00 to apply slurry seal to various (primarily residential) City streets in Council Districts 1, 5, 6 and 7. Streets are slurred by applying a quarter-inch thick coating of liquid-asphalt and sand to roadways. Slurry seal restores the pavement's ability to prevent water intrusion, corrects minor cracking and improves skid resistance. Priorities are established by a Pavement Management program the City uses to analyze and organize data collected from visual inspections of the City's roadway network. Funding for this project is included in the proposed 2020/21 Capital Improvement Program Budget.

BACKGROUND

1. This is an annual project that maintains City streets by restoring the pavement's ability to prevent water intrusion, sealing cracks, and improving skid resistance.
2. Priorities are established by the Pavement Management System and analysis of existing street sections.
3. This motion will allow for the slurry sealing of selected City streets.
4. The necessary permits have been obtained and environmental clearances completed.

PRIOR CITY COUNCIL REVIEW

ANALYSIS

1. The project was advertised on February 10, 2020. A total of seven (7) bids were received on March 11, 2020, ranging from \$499,600.00 to \$688,200.00. The low bid was 5.85% over the Engineer's estimate.
2. The low bidder, DRYCO Construction Inc., possesses a valid contractor's license of the required class, as verified by the Contractor's State License Board, and is registered with the State Department of Industrial Relations (DIR).
3. Construction is anticipated to begin July 2020. The length of the contract is nine (9) working days for completion of all slurry seal areas.
4. The project is to be funded by Measure M; no City General Fund contribution is included. Sufficient funds will be established in project key 17014 by the proposed 2020/21 Capital Improvement Program budget to be adopted by City Council which takes effect July 1, 2020.
5. It is necessary that the contract award be effective July 1, 2020, the commencement of the 2020/21 fiscal year, so that funding is in place and the project can be completed prior to the school year beginning August 13, 2020.
6. The required Public Participation Plan has been prepared by CIP staff and approved by the Transportation and Public Works Marketing and Outreach Coordinator.

FISCAL IMPACT

Approval of this contract has no additional impact on the budget, and no General Fund money is included in this project. The project is to be funded using Measure M Funding. Sufficient funds will be established in project key 17014 by the 2020/21 Capital Improvement Program budget to be adopted by the City Council, which takes effect July 1, 2020.

ENVIRONMENTAL IMPACT

This project has been reviewed pursuant to the California Environmental Quality Act (CEQA) and is categorically exempt pursuant to CEQA Guideline Section 15301, Existing Facilities. The project qualifies for this Exemption because it consists of the repair and minor alteration of an existing public facility involving no expansion of the existing use.
