

**SECOND AMENDMENT  
TO PROFESSIONAL SERVICES AGREEMENT NUMBER F000951  
WITH HARRIS & ASSOCIATES, INC.**

This Second Amendment to Agreement number F000951, dated June 2, 2015 ("Agreement") is made as of this \_\_\_\_ day of \_\_\_\_\_, 2017, by and between the City of Santa Rosa, a municipal corporation ("City"), and Harris & Associates, Inc., a California corporation ("Consultant").

**RECITALS**

- A. City and Consultant entered into the Agreement for Consultant to provide construction management services for the Stony Point Road Widening and Reconstruction Phase 2 – Sebastopol Road to Hearn Ave project.
- B. On September 20, 2017, the First Amendment to the Agreement extended the time of performance for all required tasks and services.
- C. City and Consultant now desire to amend the Agreement for the purpose of a continuation of construction support services and add post construction survey services.

**AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. Scope of Services

The first sentence of Section 1 is amended to read as follows:

“Consultant shall provide to City the services described in Exhibit A and additional services described in Exhibit A1 ("Scope of Services"). Consultant shall provide these services at the time, place, and in the manner specified in Exhibit A and A1. Exhibit A1 is attached hereto for the purpose of defining the manner and scope of services to be provided by Consultant and is not intended to, and shall not be construed so as to, modify or expand the terms, conditions or provisions contained in this Agreement.”

2. Compensation

Section 2.c of the Agreement is amended to read as follows:

“Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation shall be increased by \$250,000.00 to be paid for the satisfactory accomplishment and completion of all services to be performed hereunder shall in no event exceed the sum of Two Million One Hundred Fourteen Thousand Seven Hundred twenty-six dollars and 16 cents (\$2,114,726.16).

All other terms of the Agreement shall remain in full force and effect.
