SECOND AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT NUMBER F002333 WITH BRYCE DOW-WILLIAMSON

This Second Amendment to Agreement number F002333 dated June 29, 2021 ("Agreement") is made as of this _____ day of Agon_, 2024, by and between the City of Santa Rosa, a municipal corporation ("City"), and Bryce Dow-Williamson, a sole proprietor("Consultant").

RECITALS

- A. City and Consultant entered into the Agreement for Consultant to support special events permitting and arts programming.
- B. City and Consultant entered into the First Amendment on November 28, 2022 for the purpose of extending Time of Performance for the continuation of services.
- C. City and Consultant now desire to amend the Agreement for the purpose of increasing the Compensation, and extending the Time of Performance.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 1. Scope of Services

Exhibit A to the Agreement is supplemented by Exhibit A-1 to this Amendment.

2. Section 2. Compensation

Section 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$25,000 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of fifty-five thousand dollars and no cents (\$55,000.00). The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number GL Key 080501 and JL Keys 09704."

Exhibit B to the Agreement is replaced by Exhibit B-1 to this Amendment.

3. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

Amendment to Professional Services Agreement Form approved by the City Attorney 8-8-14 "Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than June 30, 2024."

All other terms of the Agreement shall remain in full force and effect.

EXHIBIT A-1

SCOPE OF SERVICES

Bryce Dow-Williamson will provide special event permitting and art programming services for the City of Santa Rosa.

Services will include:

- Processing and issuing a variety of event-related permits, including Special Event Permits, Film Permits, Film Permits, and Block Party Permits:
 - Processing permit applications and related fees submitted online and in-person
 - Communicating with permit applicants and various City departments regarding permit requirements and conditions
 - Scheduling and facilitating pre-event and post-event meetings
 - Monitoring compliance with applicable laws, municipal codes, policies, and procedures
- Coordinate community art programs, including exhibits, competitions, and temporary installations
- Plan and coordinate assigned cultural events, including performances and lectures
- Assist in the planning of marketing and outreach for assigned programs and projects, including preparing press releases; directing graphic designers; updating website; distributing postcards, and other collateral
- Respond to requests, complaints, and inquiries from the public related to assigned programs and events
- Prepare reports and related documents and make presentations to governmental and advisory bodies including the Art in Public Places Committee.
- Prepare and manage assigned agreements including artist service agreements, artwork loans, gifts, and licenses related to the Public Art Program.

COMPENSATION
