It is recommended by the Human Resources Department and the City Manager's Office that the Council, by resolution, adopt the Memorandum of Understanding with the Santa Rosa Police Management Association for and on behalf of the employees in the City's Bargaining Unit 9 – Police Safety Management, represented by the Santa Rosa Police Management Association, effective July 1, 2019 to June 30, 2020.

EXECUTIVE SUMMARY

By adopting this Resolution, Council will bring this bargaining unit under contract through June 30, 2020.

BACKGROUND

The City's representatives and representatives of the Santa Rosa Police Officers Association, representing the City's Unit 9 – Police Safety Management, have met and conferred concerning a successor Memorandum of Understanding and have agreed on a contract. The significant changes to the new agreement is a 2.5% salary increase effective the first full pay period following July 1, 2019;

ANALYSIS

Chapter 2-36 of the Santa Rosa City Code and the Rules and Regulations pertaining to Employer-Employee Relations adopted thereunder, establishes procedures and a

reasonable period of time for the meet and confer process to take place between the City's management representatives and representatives of recognized employee organizations, all in accordance with the provisions of the Meyers-Milias-Brown Act and applicable laws.

A summary of the changes to the Unit 9 – Memorandum of Understanding, effective July 1, 2019 to June 30, 2020:

- A 2.5% salary increase effective the first full pay period following July 1, 2019.
- Other MOU language clean-up.

### FISCAL IMPACT

The estimated cost of this Resolution is \$176,138 for fiscal year 19/20.
