It is my intention to apply for reappointment to this regional board, and I am seeking your support.

The effects of regional air quality on life in Sonoma County continue to grow. The wildfires of the past two years have reinforced just why the Air District's work is so important. These past two years have seen a record number of Spare the Air Days, a record I fear may be broken again soon. For those who are not aware, three oil companies under direct oversight of BAAQMD interfered in my city election through Independent Expenditures supporting two other candidates for the mayoral position in an attempt to knock me off the Petaluma Council and thereby eliminating me from the Air District Board. While that attempt failed, I take nothing for granted and am even more strongly committed to continuing my involvement within my city, our county, and at the regional Bay Area level.

Honorable Mayors and Council Members,

I am writing to request your support for re-appointment to the Golden Gate Bridge, Highway and Transportation District Committee. It has been an honor to serve Sonoma County for the past six years.

While moving traffic safely and efficiently along Highway 101 is our primary mission, we have made much needed significant safety improvements. The most important is the addition of the moveable median barrier which prevents tragic head-on collisions from occurring as well as working on the suicide deterrent system, which is slated to be fully implemented by January 2021.

During this time, we have implemented all electronic tolling and recently approved a new gantry system which will set above the south bound lanes. Both increase traffic flow and collection efficiencies.

We continue to look at various ways to keep traffic moving efficiently, such as increased optimization of bus routes, ferry routes and passenger capacity.

It has been a pleasure to share with the Mayors and Councilmembers the wonders of the Golden Gate Bridge Highway and Transportation District with our bi-annual tours.

The future holds much for the district including the possible addition of electric buses, alternative fuels, expansion of ferry service and increased ferry capacity.
