12.2 REPORT - RELEASE OF COVENANT RUNNING WITH THE LAND WITH SONOMA COUNTY MUSEUM UPON OFFICIAL OPENING OF THE MUSEUM EXPANSION LOCATED AT THE "EAST PROPERTY"

BACKGROUND: The Sonoma County Museum has requested that the City fully release the Covenant for the final \$50,000 on the Museum-owned property at 505 B Street upon the completion and official opening of the expansion located at 505 B Street, the East Property, as satisfaction of the Museum's remaining obligations under the Donation Agreement. The Donation Agreement and amendments thereto expressed the City's support for the expansion of the Museum for the benefit of the citizens of Santa Rosa. The proposed expansion has evolved over time since the original Donation Agreement was entered due to changing conditions, the economy and the needs of the museum. The opening of the East Property as additional museum and education facilities will benefit the community and fulfill the spirit and intent of the Donation Agreement.

RECOMMENDATION: It is recommended by the City Attorney's Office that the Council, by resolution, fully release the Sonoma County Museum from their obligations pursuant to the Donation Agreement and amendments thereto and authorize the Mayor to execute and record a Release of Covenant Running with the Land upon completion of the East Property expansion, which will fully satisfy the terms of the Covenant and the Donation Agreement.

12.3REPORT - COOPERATIVE AGREEMENT WITH CALTRANS FOR RIGHT OF WAY ACTIVITIES FOR WIDENING COLLEGE AVENUE BETWEEN MORGAN STREET AND CLEVELAND AVENUE

BACKGROUND: The widening of College Avenue between Morgan Street and Cleveland Avenue is a Caltrans project which is tentatively scheduled to begin construction in October 2013. The project will add a westbound travel lane, a left turn pocket for vehicles turning left onto northbound Highway 101 and bike lanes. Construction will take place in both Caltrans and City right of way. The total project is expected to cost approximately \$6.7 million, with the City contributing \$330,000 for right of way.

RECOMMENDATION: It is recommended by the Transportation and Public

Works Department that the Council, by resolution, 1) approve the Cooperative Agreement between the State of California and the City of Santa Rosa for right of way activities for widening College Avenue between Morgan Street and Cleveland Avenue (including authorizing the City to contribute and the State to accept \$330,000 for the purchase of right of way) and 2) authorize the Mayor to execute the Cooperative Agreement. Funding for this project has been appropriated to JL Key 17432. The source of funds are local transportation funds. No City General Fund money is included in this project.

# 12.4REPORT - APPROVAL OF THE FRANCHISE AGREEMENT FOR VEHICLE TOW SERVICES FOR THE CITY OF SANTA ROSA

BACKGROUND: On July 20, 2004, the City adopted an ordinance authorizing the Council to grant franchises to one or more tow operators for police generated tow services and requiring the payment of a franchise fee to cover the cost of the program. Tow operators placed on the City's Rotation Tow List are permitted to provide tow services to remove stopped, standing, parked, and hazardous vehicles from public streets, roads and private property. Qualified tow operators provide this service on a rotating basis. They also provide qualified storage facilities. Police Department staff is responsible for meeting annually with local tow operators, insuring compliance with the law and the tow agreement, collecting CHP 180 (tow report) forms from employees and confirming forms are property completed, and insuring notifications are mailed out as required by the California Vehicle Code. The current Franchise Agreement for Vehicle Tow Services was approved by City Council and will expire on August 31, 2013. There will be no change in the Franchise Fee unless changed Council by future resolution. а

RECOMMENDATION: It is recommended by the Police Department that the Council, by resolution, approve the Franchise Agreement for Vehicle Tow Services for the City of Santa Rosa for police generated tows and approve the proposed Tow Vendor list.
