

RESOLUTION NO. RES-2024-165

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE ISSUANCE OF A PURCHASE ORDER FOR THE PURCHASE OF TWO RESCUE AMBULANCES FROM REPUBLIC EVS IN AN AMOUNT NOT TO EXCEED \$491,728.07 UNDER THE HOUSTON-GALVESTON AREA COUNCIL (H-GAC) COOPERATIVE AGREEMENT (CONTRACT AM-10-23) AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO NEGOTIATE AND EXECUTE ANY NECESSARY AGREEMENT(S) TO COMPLETE THE PURCHASE

WHEREAS, the Fire Department submitted a request to purchase two (2) Medix Specialty Vehicles Type I ME 153” on 2024 Ford F-350 4 x 4 Diesel Powered Chassis, Two Door Standard Cab utilizing cooperative pricing from HGAC Cooperative Contract AM10-23 with Republic EVS from Huntington Beach, California; and

WHEREAS, the purchase of the two rescue ambulances will support the paramedic squad response model and replace the pickup trucks currently used by the Fire Department; and

WHEREAS, Santa Rosa City Code Section 3-08.160 allows for cooperative purchases when advantageous to the City; and

WHEREAS, the Public Safety and Prevention Sales Tax Citizen’s Oversight Committee and the City Council approved the allocation for \$500,000 for the purchase of two transport capable vehicles in the FY 2024-2025 PSAP Budget.

NOW, THEREFORE, BE IT RESOLVED that the Council approves the use of the Houston-Galveston Area Council Cooperative Agreement (Contract AM10-23) to issue a Purchase Order to Republic EVS for the purchase of two (2) Medix Specialty Vehicles Type I ME 153” on 2024 Ford F-350 4 x 4 Diesel Powered Chassis, Two Door Standard Cab, in an amount not-to exceed \$491,728.07.
