RECOMMENDATION

It is recommended by the Recreation and Parks Department that the Council, by resolution, accept a \$8,500 donation from the Santa Rosa Tennis Club and authorize the Chief Financial Officer to appropriate the donated funding to resurface courts 9 and 10 at Galvin Park.

EXECUTIVE SUMMARY

The donation from the Santa Rosa Tennis Club for resurfacing courts 9 and 10 at Galvin Community Park will improve the tennis facility and enhance the customer experience on the courts.

BACKGROUND

- Santa Rosa Tennis Club (SRTC), a non-profit organization and dedicated group of volunteers, was formed to promote tennis programs and support tennis facilities. SRTC has an active membership who have assisted with tennis court improvements such as resurfacing, purchasing new nets, trash cans, and benches. The members participate in regular court clean up days and organize events to assist with fundraising.
- 2. Recently SRTC embarked on a fundraising campaign to resurface courts 9 and 10 at Galvin Park and have raised \$8,500 for this project.

PRIOR CITY COUNCIL REVIEW

1. On April 30, 2013, the City Council approved a resolution and Memorandum of Understanding between the City and SRTC to continue their partnership to raise funds and provide support for the Galvin Park tennis courts.

- 2. On October 20, 2013, the City Council approved a resolution accepting a donation of \$17,000 from SRTC to be used toward reconstruction of Galvin Park tennis courts 5 and 6. The project was completed by the City in 2014.
- 3. On September 15, 2015 the City Council approved a resolution accepting a donation of \$15,500 from SRTC to be used toward resurfacing courts 1-4 at Galvin Park. The project was completed in May 2016.

ANALYSIS

The relationship between SRTC and the City brings funds to support tennis facilities and programs at Galvin Community Park, and provides an ongoing group of skilled volunteers to assist the Recreation & Parks Department. The resurfacing will repair extensive cracking on courts 9 and 10.

FISCAL IMPACT

The cost for resurfacing tennis courts 9 and 10 at Galvin Community Park is approximately \$11,000. This one-time donation of \$8,500 will be combined with funds remaining from the prior project and will not require additional appropriations. There is no fiscal impact to the General Fund.

ENVIRONMENTAL IMPACT

This action is exempt from the California Environmental Quality Act (CEQA) because it is not a project which has a potential for resulting in either a direct physical change in the environment or a foreseeable indirect physical change in the environment pursuant to CEQA guideline section 15378.
