Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

City of Santa Rosa PHA Plans

Project-Based Vouchers:

Comment: The RAB expressed interest in ensuring that Project-Based Voucher units are distributed evenly around different neighborhoods in the city.

Analysis: The PHA considers the city quadrant in which the project proposals are located as part of the review of each proposal and will consider quantifying this in future Requests for Proposals with a scoring system.

Comment: The RAB has concerns about the impact of Project-Based units on the Tenant-Based Housing Choice Voucher Waiting List. A household who has been waiting for longer may receive PBV assistance faster than another household if that family happens to be eligible for a particular PBV unit.

Analysis: The PHA acknowledges this scenario is possible. The offer of PBV assistance is made to the households on the Waiting List in rank order, but some PBV units have eligibility requirements based on household size (e.g., number of bedrooms in the PBV unit) or characteristics (e.g., elderly) so not all households on the Waiting List will be eligible for every PBV unit. The PHA will take this concern into consideration as additional PBV units are contemplated in the future and provide the Board of Commissioners with Tenant-Based and Project-Based Waiting List data.

Homeownership:

Comment: The RAB would like to see more focus on the Housing Choice Voucher homeownership program once the pandemic emergency has subsided.

Analysis: The PHA agrees that the opportunity to purchase a home using Housing Choice Voucher (HCV) as a means of assistance to pay the mortgage is important. The PHA's Family Self-Sufficiency (FSS) Program Coordinating Committee includes real estate professionals to connect FSS participants to homeownership opportunities. The PHA will work with neighboring jurisdictions with successful HCV programs and continue planning and implementation of the HCV homeownership option.
