1-I SENT A REGISTERED LETTER TO MAYOR NATALIE ROGERS IN ERROR
AND GOT NO REPLY-WAS IT TRASHED OR FORWARDED TO THE NEW MAYOR ?
I SENT ANOTHER REGISTERED LETTER WITH THIS INFORMATION HERE TODAY,
AND A COPY OF THE LAST ONE, TO MAYOR MARK STAPP ON 18 AUG 2025—
-PLEASE REPLY TO ALL OF MY ISSUES.

2-WHO FUNDS THE POLICE OVER SIGHT CALLED O.I.R. GROUP LLC ?
IS IT THE SANTA ROSA CITY BUDGET OR THE SRPD POLICE BUDGET ?
In November 2021, the **Santa Rosa** City Council approved the **OIR** Group LLC as the
Independent **Police** Auditor. The IPA reports to the City Manager and has full access to the
Police Department's internal investigations and tracks allegations of misconduct from
the start of a new case to the outcome and resolution phase.

3-I HAVE NOT RECEIVED A REPLY TO MY OFFICIAL COMPLAINT AGAINST
THE SRPD AND CHIEF CREGAN I SUBMITTED ON 28 JULY 2025, 3 WEEKS AGO,
WELL BEFORE ALL THE RECENT INCIDENTS OF VIOLENCE HAPPENED, WHEN
CAN I EXPECT A REPLY ?

4-WHEN WILL THE CITY COUNCIL ALSO REALIZE THAT THE POLICE FAILED FOR 4 YEARS, *FOR*4*YEARS, THEY DID NOTHING ABOUT A DRUG DEALER OPERATING OPENLY AND CREATING A PUBLIC NUISANCE ACROSS THE STREET FROM ME ?
