FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT NUMBER F002584 WITH WOODARD & CURRAN

This First Amendment to Agreement number F002584, dated 02/06/2023 ("Agreement") is made as of this ______ day of _____, 2024, by and between the City of Santa Rosa, a municipal corporation ("City"), and Woodard & Curran, a Maine Corporation ("Consultant").

RECITALS

- A. City and Consultant entered into the Agreement for Consultant to develop a Storm Drain Master Plan that would provide an actionable planning document that would supply uniformity to the decision-making process and future management of the storm drain infrastructure needs.
- B. City and Consultant now desire to amend the Agreement for the purpose of extending the schedule, providing additional effort related to missing pipe network data and to implement an alternate software for CCTV data collection, and add an additional subtask to support coordination with the Regional Board.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 1. Scope of Services

Exhibit A to the Agreement is supplemented by Exhibit A-1 to this Amendment.

2. Section 2. Compensation

Section 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$121,305.00 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of Onemillion, six-hundred ninety-five thousand, five-hundred nine dollars and no cents (\$1,695,509.00). The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number 54048 Number."

3. Section 13. Time of Performance

The last sentence of Section 13 is amended to read as follows:

"Contractor shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than March 31, 2026."
