# **EXECUTIVE SUMMARY**

The purpose of this study session is to provide information regarding two voluntary components of the Housing Choice Voucher program, Project-Based Vouchers (PBVs) and the Family Self-Sufficiency (FSS) Program.

#### **BACKGROUND**

The Housing Choice Voucher (HCV) program is a federal program under the Department of Housing and Urban Development (HUD) that provides rental assistance to low-income individuals and families which is administered by local Public Housing Agencies (PHAs). Local PHAs are overseen by the Housing Authority Board of Commissioners.

PHAs are permitted to implement a PBV program in which the PHA attaches a portion of its HCVs to specific housing units. The PBV program helps ensure that units are available to families, and helps developers finance new affordable housing units.

The FSS program is a program made available to participants of the HCV program, including PBV and other special vouchers. FSS is a voluntary program that helps

families achieve economic self-sufficiency by providing supportive services and a financial incentive through an FSS escrow account managed by the PHA.
