SUBJECT: CONTRACT AWARD – ANNUAL SLURRY SEAL 2019

AGENDA ACTION: MOTION

RECOMMENDATION

It is recommended by the Transportation and Public Works Department that the Council, by motion, award Contract No. C02251, Annual Slurry Seal 2019, in the amount of \$489,050.00 to the lowest responsive bidder, California Pavement Maintenance Company, Inc., of Sacramento, California, approve a 6% contract contingency, and authorize a total contract amount of \$518,393.00, effective July 1, 2019. Funding for this project is included in the proposed 2019/20 Capital Improvement Program Budget.

EXECUTIVE SUMMARY

This motion will award a contract to California Pavement Maintenance Company, Inc., of Sacramento, California, approve a 6% contract contingency and authorize a total contract amount of \$518,393.00 to apply slurry seal to various (primarily residential) City streets in Council Districts 6 and 7. Streets are slurried by applying a thin, quarter-inch roadway coating of liquid asphalt and sand. Slurry seal restores the pavement's ability to prevent water intrusion, corrects minor cracking and improves skid resistance. Priorities are established by the Pavement Management System.

BACKGROUND

1. This is an annual project that maintains City streets by restoring the pavement's ability to prevent water intrusion, sealing cracks, and improving skid resistance.
2. Priorities are established by the Pavement Management System and analysis of existing street sections.
3. This motion will allow for the slurry sealing of selected City streets.
4. All permits, and environmental clearances have been completed.

PRIOR CITY COUNCIL REVIEW

ANALYSIS

1. The project was advertised on March 27, 2019, and bids were received on April 17, 2019. A total of five (5) bids were received, ranging from \$489,050.00 to \$632,940.50. The low bid was 15.55% over the Engineer's estimate.
2. The low bidder, California Pavement Maintenance Company, Inc., possesses a valid contractor's license of the required class, as verified by the Contractor's State License Board, and is registered with the State Department of Industrial Relations (DIR).
3. Construction is anticipated to begin July 2019. The length of the contract is nine (9) working days.
4. The project is to be funded by Measure M. No City General Fund is included in this project. Sufficient funds will be established in project key 17014 by the proposed 2019/20 Capital Improvement Program to be adopted by City Council which takes effect July 1, 2019.
5. It is necessary that the contract award be effective July 1, 2019, the commencement of the 2019/20 fiscal year, so that the funding is in place and the project can be completed prior to the school year beginning August 14, 2019.
6. A Public Participation Plan is required and has been approved by the Transportation and Public Works Marketing and Outreach Coordinator.

FISCAL IMPACT

Approval of this contract has no additional impact on the budget, and no General Fund money is included in this project. The project is to be funded using Measure M Funding. Sufficient funds will be established in project key 17014 by the 2019/20 Capital Improvement Program to be adopted by City Council, which takes effect July 1, 2019.

ENVIRONMENTAL IMPACT

This project is Categorically Exempt pursuant to CEQA Guideline Section 15301 because it consists of the repair and minor alteration of an existing public facility involving no expansion of an existing use.
