RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA TO INCREASE APPROPRIATIONS IN FUND 1650 JL KEY 45138 BY \$60,000 AND COOPERATIVELY PURCHASE SIX REPLACEMENT PARATRANSIT BUSES FROM CREATIVE BUS SALES OF CALIFORNIA FOR A TOTAL OF \$376,998.30.

WHEREAS, six of the existing thirteen paratransit vehicles in the Santa Rosa Paratransit fleet exceed the scheduled useful life for this type of vehicle based upon federal regulations; and

WHEREAS, the Morongo Basin Transportation Authority (MBTA) Purchasing Cooperative has conducted a competitive procurement in accord with City Code Section 3.08-160 for Paratransit fleet vehicles; and

WHEREAS, the MBTA Purchasing Cooperative has performed all of the state mandated procurement requirements and the Purchasing Agent has deemed it competitive and advantageous to the City; and

WHEREAS Creative Bus Sales of Chino, CA is the low-cost bidder in the MBTA cooperative procurement and has provided a price of \$62,883.05 per Paratransit bus with a total six-bus cooperative procurement price of \$376,998.30; and

WHEREAS, the FY2013-14 Operations & Maintenance Budget includes California State Proposition 1B Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) revenue for replacement bus acquisition.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa authorizes the cooperative purchase of six (6) Paratransit buses from Creative Bus Sales for a total of \$376,998.30, the source of funds to be Fund 1651 – JL Key 45138.

BE IT FURTHER RESOLVED that the Council authorizes the Chief Financial Officer to increase appropriations in Fund 1651 – JL Key 45138 by \$60,000 via a transfer, with the source of funds being Fund 1270 – Transit Prop 1B, for total appropriations of \$390,000.

BE IT FURTHER RESOLVED that the Council authorizes the Chief Financial Officer to pay all proper claims for this purchase from Fund 1651 – JL Key 45138.
