RECOMMENDATION: It is recommended by the Housing and Community Services Department that the Housing Authority, by resolution, approve the submittal of a grant application to the California Department of Housing and Community Development in the amount of \$5,000,000 in CalHome funds and authorize the execution of a Standard Agreement and any related documents necessary to participate in the CalHome Program, to provide downpayment assistance and housing rehabilitation loans to eligible households in Santa Rosa.

Megan Basinger, Executive Director, answered questions from Commissioners.

David Harris spoke with questions on how the Housing Authority would prioritize fund allocations if awarded the CalHome grant.
