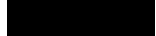

Dear Mayor, City Council Members and Staff:

I am writing on behalf of Legal Aid of Sonoma County to urge that you reconsider your proposed cuts to Legal Aid of Sonoma County's funding.

We sincerely empathize with the burden this council must carry, and we understand that you are considering a series of impossible choices. That said, we implore this council to reconsider the proposal to not renew its contract with Legal Aid of Sonoma County (LASC).

Since 2017, the City of Santa Rosa has contracted with LASC to provide housing rights and eviction defense services to low-income city residents and low-income landlords. For \$111,000, LASC provides robust services to the City's most vulnerable residents, most of whom are one unexpected cost away from potential homelessness.

Since we began contracting with the City, LASC has assisted a total of **2,131 low-income tenant households in Santa Rosa** with housing rights and eviction defense services. In our last contract year, **from July 2023 through June 2024**, LASC provided **443 low-income tenants with legal education**, provided **legal services to 274 tenants**, which included **preventing at least 73 households from eviction or displacement** and addressing **habitability issues for at least 43 households**. LASC also assisted **11 low-income landlords** with legal services.

Thus, **this equates to a cost of about \$155 per household to prevent homelessness**, as compared to the estimated annual average **cost for public services per homeless person of between \$60,000 and \$100,000** as reported in a 2017 Sonoma County Grand Jury Report.ⁱ Thus, for every dollar spent preventing homelessness, the city saves exponentially on other costs, including the City's nearly \$6 million spent on homeless services.ⁱⁱ

Additionally, the figures presented do not capture the full financial impact of LASC's advocacy, particularly the dollars reinvested into the City through direct client support. LASC routinely helps vulnerable tenants avoid crushing debt, —whether from unpaid rent or court-related costs—and, in some cases, secures substantial financial recoveries on their behalf. In 2024, for example, LASC represented a group of severely at-risk tenants in Santa Rosa who had been living in hazardous, substandard conditions under a negligent and exploitative landlord. When the property was red tagged, these tenants faced imminent homelessness, with no relocation assistance or compensation offered. Thanks to LASC's contract with the City, LASC was able to intervene and ultimately secure a settlement of over \$80,000 for these tenants, a sum nearly equivalent to the total cost of the City's contract with LASC, and one that directly benefits the local economy.

Finally, **without this funding, LASC's ability to serve vulnerable tenants in Santa Rosa is at serious risk.** Although we've long received County support through the CDBG Fair Housing set-aside, these funds specifically **exclude** services within **Santa Rosa** and Petaluma, due to each jurisdiction's own CDBG allocation. And, LASC was discouraged from applying for Santa Rosa's CDBG Fair Housing set-aside in 2025. though LASC was awarded one-time discretionary general fund dollars last year to provide tenant services countywide, those funds will expire in June 2025. Thus, without renewed support from the City, our ability to assist Santa Rosa tenants will be drastically reduced and, we believe, will directly impact the City's housing and homelessness crisis.

As such, we ask that you reconsider your proposal and continue to fund Legal Aid of Sonoma County's housing rights and eviction prevention program.

City Council Members,

I strongly considered delivering a public comment in person tomorrow but ultimately felt that a written message would be the most effective and appropriate way to communicate my concerns as you provide guidance on the upcoming budget cuts.

I am writing on behalf of not only myself, but the Santa Rosa Police Management Association (PMA). We feel deeply betrayed by actions taken by some members of the City Council. Both the PMA and the POA have continuously worked in good faith with the City - during contract negotiations and more recently in discussions about budget reductions. We have refrained from inflammatory social media campaigns designed to pressure or embarrass the City. Instead, we were the first labor union to come to the table when asked, and we focused on finding solutions, not creating conflict. At one point, the PMA even declined additional compensation offered during negotiations – demonstrating our willingness to collaborate and prioritize the City's needs.

In return, we are facing disproportionate cuts to our department—cuts that are not backed by data. Meanwhile, another union that rejected a historic contract offer last summer and chose to rally public sentiment through social media, rather than working with City leadership, is being spared. This sends a troubling message about how the City values cooperation.

The Santa Rosa Police Department responds to an average of over 320 calls for service each day. On one of our busiest days, we handled more than 100 calls in a single hour. In contrast, the Fire Department averages about 75 calls per day. Many police calls are high-risk, requiring experienced leadership to manage effectively. Reducing our already limited command staff—especially lieutenants—heightens the City's liability. For context, departments our size typically have 10 lieutenants; our last staffing study indicated that we were negligent for not having more. We simply cannot afford to cut further from our ranks just to avoid browning out a firehouse.

Moreover, the Fire Department's reported call volume is misleading. They have included calls handled by inRESPONSE, even though that unit does not diminish their capacity for traditional fire service. Additionally, Fire Chief Westrope noted that roughly 70% of their calls are EMS-related. In my nearly 20 years in law enforcement, I've been present at many of these medical calls. In most cases, firefighters ask the same basic questions I do and then wait for an ambulance to arrive. Occasionally they check vitals, but it's rare to see them provide meaningful medical care. Anyone who participates in a ride-along will observe this multiple times per shift.

If 70% of fire calls fall into this category and their numbers are further inflated by including inRESPONSE, we need to ask: what is the actual workload and liability? The City absolutely should consider browning out a firehouse before eliminating any more police officers—particularly lieutenants. When it comes to reducing liability and ensuring public

safety, well-trained officers and supervisors are indispensable. A fire engine waiting with a patient until an ambulance arrives does not mitigate City liability the way professional police response does.

There is ample data available showing which departments shoulder the most responsibility and risk. I urge you to make budget decisions based on facts and data—not emotion or political pressure. I understand the fear and urgency that surrounded the fires of 5–8 years ago. But current staffing levels in the Fire Department are not supported by today's data. Conversely, outside reviews and internal assessments alike continue to confirm that the Police Department—especially at the lieutenant level—is understaffed.

Please don't reward the disruptive tactics of one union by cutting from the one that has been working with you from the beginning. Make the tough decisions where the evidence points—not where the pressure is loudest.

My name is Sara Roberts and I am a City of Santa Rosa employee and a Teamsters Local 856 shop steward.

I take issue with the fact that a year ago we were given a minute each to speak, and during the meeting today were denied the opportunity to speak in solidarity with each other. Why would you not want to hear from people that represent your organization daily?

I was born, raised and have chosen to raise my own family in this City. Besides a brief period when my husband and I were first married, I have proudly lived my entire life within these City limits. I was so excited when I got my job offer to become a public servant for the city I call home. I was hired in one of the first hiring groups after the recession, as a senior administrative assistant, so I have lived through the aftermath of decisions that you are undertaking. I know they were felt long after the recession ended, and some departments and teams were never made whole again, if not in numbers, definitely in morale.

I know my fellow members have shown up for this City at midnight in firestorms, stayed for days during the recovery from those fires, risked their health during the pandemic to serve the public, and have endured the uncertainty of the past few weeks without a reduction in

the quality of service the public expects.

I want to take this moment to remind you that those people aren't just your employees and numbers in a forecast, they are more than likely your constituents, participants in the programs and events this City puts on, and are your best ambassadors to their friends and neighbors. When you make that decision to eliminate their livelihoods, you are making a family in your City less secure, and possibly ruining their foreseeable future. You are telling someone who likely puts this City first above themselves and sometimes their families, that they are a number to be reduced.

You negotiated and settled on a contract less than a year ago with my unit, and also with my fellow Teamsters in the miscellaneous units, and our brothers and sisters in SEIU and OE3. The proposal, less than a year later, to cut the pay of your employees through illegal furloughs and eliminating filled positions flies in the face of those agreements.

When I retired in 2016, I joined exercise classes and the Bill's Beginners & Beyond Ukulele classes.

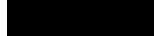

Dear Mayor and Councilmembers,

My name is Matt North, and I am a 27-year law enforcement professional who has proudly served in key leadership roles within the Santa Rosa Police Department.

I'm reaching out to express deep concern over the proposed elimination of my Lieutenant position. While this may appear to be a modest cut on paper, the reality is far more consequential—both operationally and legally.

Santa Rosa's population has continued to grow over the past three decades, yet police staffing has not kept pace. In 1990, we had 1.19 officers per thousand residents. By 2025, that number has dropped to just 1.05 per thousand, along with a 21% decrease in civilian staff. These reductions have created a dangerous gap in both front-line resources and supervisory oversight.

The elimination of a Lieutenant from our already lean command structure presents a clear liability risk. As one of only a few mid-level leaders bridging field operations and executive management, I provide direct oversight during use of force incidents, pursuits, internal performance matters, and critical incident response. Reducing leadership at this level increases span of control, dilutes accountability, and exposes the City to foreseeable claims of inadequate supervision or failure to train.

Leadership gaps are rarely obvious—until something goes wrong. And when it does, the first question asked is: “Who was in charge?”

Beyond that, I ask you to consider the human impact. This proposal effectively ends my leadership role in a city I've been proud to serve and represent through some of its most difficult moments. I've built trust, led teams, built and fostered relationships across our great community, and helped uphold the department's integrity backed by nearly three decades of experience, consistency, and a deep understanding of this community. My current rank has also afforded me the opportunity to represent the City of Santa Rosa in a positive light—collaborating with regional partners, teaching for POST supervisory courses, and mentoring the next generation of law enforcement leaders. That credibility comes from the position I hold, not just the work I do.

I respectfully urge you to reconsider this particular reduction—not only for what it removes in the short term, but for what it may cost the City long-term in operational continuity, civil liability, and community confidence.

Thank you for your time and leadership during this difficult process.

Firefighter Opposition to Budget Proposal Eliminating Ladder Truck

Dear Mayor and Members of the City Council,

As a citizen I am submitting this letter to bring to your attention what appears to be a violation of the Brown Act. During the meeting on May 5th, 2025 you held a “Regular Meeting”. During which you also included a study session without public comment. This is a violation of Government code and the brown act. Please see my comments below.

As a firefighter for You and the City of Santa Rosa, I am writing to express my deep concern and professional opposition to the current budget proposal that would eliminate one (1) of your department’s two (2) ladder trucks.

From where I stand—on the front lines—this is not simply a budget line item; it’s a decision that will directly impact public safety,..... firefighter safety,..... and the level of service we can provide to the community we are sworn to protect.

I want to be absolutely clear: ladder trucks are **not** specialty tools used **only** in rare situations as inferred in the budget packet.....They are vital components of our daily operations. They carry critical equipment that engines do not carry.

And last but not least

- <!--[if !supportLists]-->• <!--[endif]-->Elevated water streams.....They are the only option to provide access to multi-story buildings, which are increasingly common in our city and are indispensable during structure fires and complex rescues. When a ladder truck is not available, it is not a matter of delayed service—it’s a matter of compromised service.

Beyond the impact to the public, removing a ladder truck puts **firefighters at greater risk**. These trucks are staffed with personnel whose primary roles include ventilation, search and rescue, and rapid intervention. When those functions are delayed or not available, the conditions inside a fire deteriorate quickly, making it significantly more dangerous for us and victims alike.

Fewer resources mean more risk, slower operations, and a greater chance that someone—civilian or firefighter—doesn't make it out.

As you are aware, Santa Rosa voters just approved **Measure H**, intended to *enhance* fire protection and emergency response—not diminish it. Cutting one of our two ladder trucks immediately after this voter-approved mandate sends the wrong message. It suggests the city is not honoring the intent of the measure or the trust that residents placed in their fire department when they voted in favor of increased investment in our services.

We are already stretched thin. Calls for service are increasing, fire risks are growing, and our city continues to grow. Eliminating a critical unit like a ladder truck at a time like this is not just poor planning—it's dangerous.

It makes our job harder, increases response times, reduces our ability to perform key tasks, and places an unfair burden on the remaining crews and equipment.

As an employee under your care, I urge you to reconsider this proposal. Please do not reduce the tools and personnel we rely on to do our jobs safely and effectively. The residents of Santa Rosa deserve a fire department that is fully equipped to meet their needs—and so do the men and women who risk their lives to protect them.

Good Morning,

While I unfortunately missed yesterday's budgeting study session, I had the opportunity to attend the non-agenda public comment period during the regular afternoon calendar.

It was upsetting to hear the remarks made by City Staff represented by Teamsters 856. Your staff has felt excluded from sharing the feedback on the budgeting process. Because they are scheduled to work while the study sessions take place, how can they genuinely be included? Written comments submitted to Council often go ignored and stakeholders should have the opportunity to provide verbal public comments.

For reference, I have attached the agenda for the County of Sonoma's annual 3-day budgeting session. Per the agenda, comments on the budgeting session are allowed every single day, even though the presentations are split over a 3-day period. Because the County of Sonoma has permitted their staff multiple comment periods, why has the City of Santa Rosa refused to offer the same opportunities. How does exclusion align with the City's newly adopted equity [policy](#)?

While this does not serve as an official Cure & Correct letter, I am seeking a response from the City's legal team regarding the following:

Per [Lozano Smith](#) Attorneys at Law:

Each regular meeting agenda must provide an opportunity for public comment on any agenda item and on any item of interest to the public within the subject matter jurisdiction of the legislative body. For special meetings, the agenda must provide an opportunity for members of the public directly to address the legislative body concerning any item on the agenda; comments on items not on the agenda need not be allowed.


Based on The Brown Act, the City's attached agendas for May 6 & 7, 2025 present a potential violation of the Act. Legally, public comments should have been permitted for the study session on both days. In lieu of sending an official Cure & Correct Letter to the District Attorney, I am requesting for Council to hold an evening public comment period following the study session at a future date before officially taking action on budget cuts.

City Council Members,

I strongly thought about delivering a public comment in person tomorrow, but a written message would be the most effective way to communicate my concerns as you provide guidance on the upcoming budget cuts. This will allow me to fully express my feelings without getting overly emotional.

I am writing on behalf of not only myself, but the Santa Rosa Police Management Association (PMA). We feel deeply betrayed by the actions taken by some members of the City Council. The PMA and the POA have continuously worked in good faith with the City during contract negotiations and, more recently, in discussions about budget reductions. We have refrained from inflammatory social media campaigns designed to pressure or embarrass the City. Instead, we were the first labor union to come to the table when asked, and we focused on finding solutions, not creating conflict. At one point, the PMA even declined additional compensation during negotiations, demonstrating our willingness to collaborate and prioritize the City's needs.

We put our trust in you and our City Manager.

In return, we are facing disproportionate cuts to our department—cuts that are not backed by data. Meanwhile, another union that rejected a historic contract offer last summer and chose to rally public sentiment through social media, rather than working with City leadership, is being spared. This sends a troubling message about how the City values cooperation.

The Santa Rosa Police Department responds to an average of over 320 calls for service each day. On one of our busiest days, we handled more than 100 calls in a single hour. In contrast, the Fire Department averages about 75 calls per day. Many police calls are high-risk, requiring experienced leadership to manage effectively. Reducing our already limited command staff—especially lieutenants and sergeants—heightens the City's liability. For context, departments of our size typically have 3 Captains, 10 lieutenants; our last staffing study indicated that we were negligent for not having more supervision. We cannot afford to cut further from our ranks to avoid browning out a firehouse. Other cities in the Bay Area are brownout stations to overcome budget constraints.

Moreover, the Fire Department's reported call volume is misleading. They have included calls handled by inRESPONSE, even though that unit does not diminish their capacity for traditional fire service. Additionally, Fire noted that roughly 70% of their calls are EMS-related. In my nearly 24 years in law enforcement, I've been to many of these medical calls. In most cases, firefighters ask the same basic questions the police do and then wait for an ambulance to arrive, or they arrive after the ambulance and don't get off their fire truck and keep driving. Occasionally, they check vitals, but it's rare to see them provide meaningful medical care. Anyone who participates in a ride-along will observe this multiple times per shift.

Also, I'd like to ask frequently: Why does the Fire Department not work shifts like the police department? Does the Fire Department need the same number of firefighters at 3 AM as they do at 3 PM? The police department does not. Both Fire and Police have access to mutual aid should an incident arise. Good leaders make it work.

If 70% of fire calls fall into this category and their numbers are further inflated by including inRESPONSE, we need to ask: What is the actual workload and liability? The City absolutely should consider browning out a firehouse before eliminating any more police officers—particularly lieutenants. When it comes to reducing liability and ensuring public safety, well-trained officers and supervisors are indispensable. A fire engine waiting with a patient until an ambulance arrives does not mitigate City liability like a professional police response does.

There is ample data available showing which departments shoulder the most responsibility and risk. I would like you to make budget decisions based on facts and data, not emotion or political pressure. I understand the fear and urgency that surrounded the fires of 5–8 years ago. But current staffing levels in the Fire Department are not supported by today's data. Conversely, outside reviews and internal assessments alike continue to confirm that the Police Department—especially at the lieutenant level—is understaffed.

As a fire survivor, browning out a station does not concern me and when looking at the facts, I support it.

Please don't reward one union's disruptive tactics by cutting from the one that has been working with you from the beginning. Make the tough decisions where the evidence points, not where the pressure is loudest.

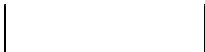

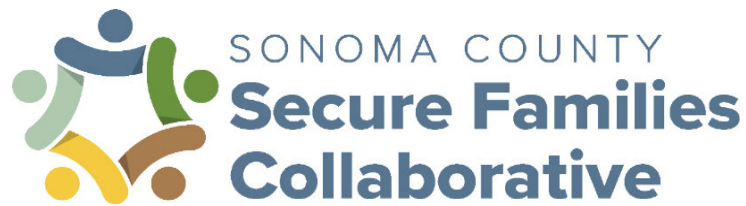

I. RESPONSE OF THE SECURE FAMILIES COLLABORATIVE TO RAPIDLY CHANGING IMMIGRATION POLICIES

Since 2018, The Secure Families Collaborative (SFC) has remained steadfast in its commitment to ensuring that immigrant families are informed, supported, and empowered amid shifting and often unpredictable immigration policies. In recent months, we have witnessed the sharp erosion of legal pathways to citizenship and a breakdown in due process protections. These changes are not only impacting individuals with criminal histories, but are broadly threatening our entire immigrant community. Families face separation, transfer to out-of-state detention centers with inhumane conditions, and deportation to countries they have not lived in for decades.

SFC is uniquely positioned to respond to this crisis through our integrated model of legal services, outreach and education, and community-based support. With the support of the City Council of Santa Rosa, we can continue to scale our efforts to protect vulnerable families, uphold fundamental rights, and promote long-term stability and justice for immigrant communities across the county.

II. HISTORY - BUILDING SONOMA COUNTY'S REMOVAL DEFENSE CAPACITY IN THE FACE OF FAMILY SEPARATION

The Board of Supervisors established the Secure Families Fund, presently known as the Sonoma County Secure Families Collaborative (SFC), to increase removal defense capacity in Sonoma County. SFC employs a unique collective impact model to provide comprehensive support to county immigrants. The Collaborative continues to offer *pro bono* removal defense and other immigration legal services, along with essential wraparound social service navigation. It prioritizes community collaboration by partnering with community-based organizations to achieve grassroots collective impact.

As highlighted in Sonoma County Board of Supervisors Resolution #2021-0427, more than one in four county residents (120,000 individuals) have a family member without legal status who could face separation from their families through deportation. This affects both long-term immigrants who have contributed to the Sonoma County economy for years and newer immigrants arriving from dangerous situations in countries like Ukraine, Palestine, Venezuela, Haiti, Nicaragua, and other Central American nations. These groups would be at risk of persecution, violence, or death if forced to return to their home countries.

III. INNOVATING FOR IMPACT: SFC'S FOUR 2025 PILLARS - A NEW PHASE OF OUR COLLABORATIVE MODEL

SFC's current emphasis on four pillars is grounded in extensive community input and analysis and will serve as the foundation for our new strategic plan.

Pillar One: Expand *pro bono* removal defense capabilities and related immigration legal services.

Pillar Two: Facilitate resource navigation.

Pillar Three: Attorney-informed education, outreach and resources

Pillar Four: Provide fundraising guidance and support to immigrant-serving nonprofits and community-based organizations in all County supervisorial districts.

PILLARS DEFINED:

Pillar One - *Expanding pro bono removal defense capabilities and related immigration legal services*

The Collaborative has significantly increased its capacity to meet the growing demand for *pro bono* removal defense and affirmative legal services.

After beginning with **two** attorneys in 2018, the Collaborative will have a team of **seven** legal staff members, including **six** attorneys in 2025:

- USF - Jacqueline Brown (Removal Defense)
- USF Legal Fellow (Removal Defense - to begin in August)
- SIS - Vicki Handron (Affirmative)
- SIS - Bernice Espinoza (Removal Defense) /Santa Rosa office
- SIS - Maureen McSorley (SIJS) /Santa Rosa and Windsor offices
- Catholic Charities - (Removal Defense -to begin in spring 2025) Santa Rosa
- Catholic Charities - (Removal Defense- to begin in summer 2025) Santa Rosa

Pillar Two - *Resource Navigation*

Hand Holding, not Warm Handoffs or Cold Referrals

In 2024, the Collaborative brought on Beth Aldridge, an experienced healthcare administrator with over 40 years of experience, to serve as Resource Navigator. In collaboration with Jessica Magana Carmona, SFC's bilingual and bicultural Outreach Coordinator, Beth is spearheading a transformation in resource navigation delivery. These SFC staff are dedicated to offering hands-on support throughout the entire process to ensure clients receive accurate information and timely assistance.

Upon discovering that many publicly available resource guides were outdated and unreliable, Beth also developed an internal resource guide with regularly updated, vetted information - ensuring clients receive accurate, timely support every time. She created this guide, which now contains over 300 community-based organizations, where county immigrants can receive crucial support. This guide and the information collected from the Local Immigration Integration and Inclusion Grant's (LIIG) community-based organizations (CBO) survey project will be shared with 211 to update their resources.

Due to an increase in demand, SFC has expanded its resource navigation team this year to include youth-specific support. Marsha Sendar, a dedicated volunteer, will now focus solely on assisting youth clients (21 and under). She will work closely with SFC's SIJS attorney, Maureen McSorley, to ensure that young people receive tailored wraparound support.

Building on Existing County Infrastructure in Collaboration with EDC and United Way of the Wine Country

The Secure Families Collaborative, in partnership with the Economic Development Collaborative of Sonoma County, was awarded the California Board of Governors' LIIG grant. This grant has provided support for two projects. The first project is an ongoing survey of Sonoma County's immigrant-serving CBOs. This study's goal is to identify organizations' current capacity and gaps in service provision. The results will be used to update the county website's immigrant service provision section and will be shared

with the United Way of the Wine Country to update their 211 resources.

The second project consists of individual surveys being collected at six immigrant-serving “survey clinics” across all county supervisorial districts to assess the critical needs of immigrant communities. This data will be aggregated and presented to the Board of Supervisors (and shared with the City Council of Santa Rosa) to help develop an innovative and responsive model that is sensitive to current immigrant needs. Additional Sonoma County organizations are also being identified to ensure cross-organizational collaboration and eliminate service duplication.

Pillar Three - Attorney-Informed Community Outreach

The Collaborative’s innovative model prioritizes education and outreach. As a community-informed organization, SFC listens to immigrant priorities and provides timely information and connection, bridging the gap between legal services providers, CBOs, and immigrant families. We provide access to critical resources and trustworthy information at trusted community spaces.

Jessica Magana, the Collaborative’s bilingual and bicultural outreach coordinator, plays a key role in connecting our organization with its served community. As a Sonoma County local and daughter of immigrant parents, Jessica is intimately aware of the immigrant experience and is uniquely qualified to reach immigrants where they are.

Pillar Four - Fundraising and Fund Development Support for CBO’s

By the end of 2025, SFC will have raised over **seven million dollars** since its inception, **85 percent** of which will have been distributed directly to immigrant-serving organizations. This would not be possible without the annual grant from the City Council of Santa Rosa. This funding has built community trust in the Collaborative and validates the Collaborative’s impact, governance, and alignment with public priorities - often opening doors to additional philanthropic and institutional support.

The following is a list of local CBOs and nonprofit organizations that have received / continue to receive funding from the Secure Families Collaborative:

The Collaborative has seven years of experience in fiscal management and programmatic oversight. Most recently, the County Board of Supervisors decided to grant \$500,000 (75K admin.) in pass-through funding for immigration services and outreach to the Collaborative. As such, SFC is now responsible for administering \$425,000 in pass-through funding on behalf of the County. This funding will be distributed to immigrant-serving CBOs and/or immigration legal service providers in the County. (This also attests to the need for additional funding for SFC, as the Collaborative’s administrative role in this pass-through funding disqualifies it from receiving said funding.)

The Collaborative assembled an external and impartial grant review committee to expeditiously review proposals. SFC will be responsible for the management, oversight, and data accumulation / management for the County Administrator's Office. Gina Carter, an accomplished retired attorney, has volunteered to assist the Secure Families' administrative team with grantee management and oversight to ensure SFC meets all expectations outlined in the county scope of work.

In addition to programmatic and fiscal oversight, the Collaborative provides *pro bono* fundraising capacity-building services to organizations requiring assistance with grant writing. Recently, the Collaborative facilitated a removal defense grant application to the California Department of Social Services (CDSS) on behalf of Sonoma Immigrant Services. SFC also secured grants from local foundations to support Queer Asylum Accompaniment. Lastly, SFC has pledged support to the Development Department at Catholic Charities of Northwest California to mitigate their budget deficit resulting from the recent defunding of the U.S. Citizenship and Immigration Services (USCIS) grant.

Secure Families is also working in collaboration with other funders in the county - the Community Foundation Sonoma County, the Evelyn and Walter Haas Jr. Fund, the Catalyst Fund, and First 5 Sonoma County.

IV. KEEPING SONOMA COUNTY IMMIGRANT FAMILIES TOGETHER

The Sonoma County Secure Families Collaborative remains committed to adapting and evolving to address the unprecedented challenges facing the County's immigrant communities. By providing effective and innovative legal services, as well as vital and supportive social services, the Collaborative does everything possible to keep immigrant families together.

Due to seemingly overwhelming challenges at the federal level, swift collective action from local actors is needed, including the state and county government. Despite overwhelming obstacles, the Collaborative, through a coordinated effort with county, city, legal and social service partners, continues to offer hope and a literal lifeline to Sonoma County immigrants.

The Collaborative's provision of services to the County's immigrant communities has been critical to support public health and safety. We also ensure these communities access aid and other resources. Many undocumented immigrants are ineligible for federal benefit programs, but they need counsel before applying for or accepting some forms of public benefits, as this could put their ability to become legal residents at risk. By providing legal answers on public assistance questions, the Collaborative can secure family health and safety in the short term and emphasize long-term immigration options.

The Collaborative is committed to a grassroots, community-centered approach. This positions us well to continue to provide critical legal and supportive assistance. As such, the Collaborative will expand its social service navigation, increase partner numbers, continue to emphasize geographic diversity to serve all areas of the County, and streamline coordination among agencies and law firms offering immigration legal services. Such coordination and leadership are crucial to effectively responding to current immigration challenges and promptly mobilizing limited legal resources to meet the needs of all immigrant residents of Sonoma County, both documented and undocumented.

The Collaborative will also enhance its relationships with other legal service providers to meet frequently-changing legal needs. These efforts will include an initial forum on upcoming policy changes, cross training between agencies, and the development of a coordinated response for efficient interagency collaboration and mobilization.

An integral component of the Collaborative's structure is continual learning from clients about how best to support their collective and individual needs. Similar to the federal government's policies, our proactive approach is constantly evolving and is community-centric. The Collaborative was founded on a commitment to stand with the over 42,000 undocumented Sonoma County community members (as per Undocufund) impacted by federal immigration policies.

V. COLLABORATIVE PARTNERSHIPS

As an imperative component of its success, the Collaborative builds on the work of existing organizations. Current Collaborative partners include: the USF Immigration and Deportation Defense Clinic - Healdsburg (USF); The United Way of the Wine Country - Santa Rosa; Sonoma Immigrant Services - Sonoma and Santa Rosa (SIS); Nuestra Comunidad - Windsor; Queer Asylum Accompaniment - Sebastopol (QAA); the Sonoma County Economic Development Collaborative (EDC); and Catholic Charities Diocese of Northwest California - Santa Rosa (CCNWC).

These strategic partnerships ensure the Collaborative's long-standing goal of reaching each County geographic area is met. By supporting existing organizations and facilitating broad-based coalition work through the direct involvement of immigrant communities, we multiply our collective impact. As a core organizational value, we believe that we are stronger together than working independently. These current partners will build upon past successes.



The USF Immigration and Deportation Defense Clinic (Healdsburg) continues in a leadership role in immigration legal services. USF is an invaluable collaborative resource due to its position as both educator and service provider. Jacqueline Brown is a nationally renowned immigration and removal defense expert. As the Collaborative's Legal Director, she will continue to provide *pro bono* assistance with removal defense cases and supervise the Collaborative's partners' legal teams. She also works with Gina Garibo at the North Bay Rapid Response Network to set up an "attorney of the week". Moreover, nationally renowned Attorney Bill Ong Hing, Founder of the USF Immigration and Deportation Defense Clinic and the Immigrant Legal Resource Center (ILRC), advises partner legal teams on an as needed basis.



Sonoma Immigrant Services (Sonoma Valley, Santa Rosa, and Windsor) prioritizes their mission of strengthening the community through education and advocacy, including immigration legal services. Like the USF Immigration and Deportation Clinic, they offer *pro bono* representation to families or individuals in removal proceedings.

Sonoma Immigrant Services (Sonoma Valley) continues to lead the Collaborative's immigration and outreach efforts, providing citizenship classes, Know Your Rights training, training the trainer

opportunities, and general immigration outreach at schools, community spaces, immigrant resource centers, and similar locations.

Sonoma Immigrant Services (Santa Rosa) - Bernice Espinoza has 14 years of prior experience as a public defender and specializes in the intersection of criminal law and immigration. This office also provides outreach, education, and advocacy.

Sonoma Immigrant Services (Windsor) - Maureen McSorley, who has over 32 years of experience and is a renowned expert on Special Immigrant Juvenile Status (SIJS) cases, fulfills a demonstrable need among Sonoma County's immigrant youth.



In 2025, Catholic Charities of Northwest California (CCNWC) will play a critical role in the Collaborative as a direct immigration legal services provider and educator. CCNWC has been a cornerstone of support for Sonoma County's immigrant community for over 50 years, providing essential immigration legal services to over 3,000 immigrants annually. Their team of DOJ accredited representatives and attorneys (Two will be joining the team this year.) offer a wide range of services, including assistance with citizenship applications, family petitions, DACA renewals, and deportation defense. Additionally, CCNWC plays a vital role in educating the community through citizenship classes and Know Your Rights workshops, empowering immigrants with knowledge and resources.

Recent funding cuts have forced CCNWC to implement fees for their services, creating a financial barrier for many low-income immigrants who are already struggling. This situation is particularly dire given the current political climate, where anti-immigrant rhetoric and policies have created a climate of fear and uncertainty. The increased demand for legal services, coupled with the funding shortfall, has created an urgent need for additional financial support to ensure that CCNWC can continue to provide accessible and affordable legal services to those who need them most.



Queer Asylum Accompaniment (Sebastopol) will continue to support LGBTQIA+ asylum seekers. QAA is a component of the North Bay Rapid Response Network (NBRRN) and assists asylum seekers with essential needs such as housing, food, and social services. Queer Asylum Accompaniment is a local community of volunteers dedicated to welcoming and supporting at-risk LGBTQIA+ people to start new lives in Sonoma County.

North Bay Organizing Project (Countywide) - USF and other immigration legal services partners work in collaboration with NBOP and the North Bay Rapid Response Network (NBRRN) to set up an “attorney of the week” to ensure immigrants receive timely support and advice from a trusted, expert attorney.



United Way of the Wine Country (Santa Rosa / Countywide) envisions a day when all families are empowered to gain access to the resources and opportunities they need to achieve financial stability and contribute to the well-being of our shared communities. They will work with the SFC Administrative Team and the County's Economic Development Collaborative to update their 211 resource directory based on data received from CBO survey results. The United Way is a BIPOC-led partner collecting immigrant surveys, facilitating an accurate assessment of current needs and experience for Sonoma County immigrants. They will collect at least 1,000 surveys in 2025.



Nuestra Comunidad (Windsor), the County's first resilience hub, is dedicated to improving the health, safety, and well-being of the County's immigrant community. They foster a culture of preparedness and train immigrant allies. They provide office space as-needed to immigration attorney staff.



The Sonoma County Economic Development Collaborative (Countywide) is focused on growing a healthy economy by helping businesses in Sonoma County. In partnership with the United Way and the SFC Administrative Team, EDC jointly manages the California Board of Governors' Local Immigration Integration and Inclusion Grant (LIIG). This grant supports two critical research projects explained in greater detail in the application.



The County of Sonoma Board of Supervisors granted \$500,000 (\$75,000 of which is administrative funding) in pass-through funding for immigration services and outreach to the Collaborative. As such, the County and SFC jointly administer \$425,000 in pass-through funding. This funding will be distributed to immigrant-serving CBOs and County immigration legal service providers. The County and the Collaborative will coalition build throughout 2025 with grant recipients.

In addition, the Collaborative is working with the County's Communication Team to update the county's immigrant services webpage.



The Petaluma Family Resource Center (Petaluma) supports vulnerable immigrants enrolled in Petaluma City Schools and their families. With support from Secure Families and the City of Petaluma, the Petaluma Family Resource Center will be providing immigration legal services consultations, naturalization workshops, referrals, Know Your Rights events, and Family Preparedness Plan workshops with IIBA, Lideres del Futuro, and VIDAS

VI.

CONCLUSION

The federal government has made their intention to oppress immigrants clear. As such, addressing the challenges facing the immigrant community cannot wait. The Secure Families Collaborative continues to serve as a legal and social service lifeline to Sonoma County's immigrant community. The Collaborative is committed to bringing together existing organizations, adding legal resources, and listening to clients regarding essential needs.

The Collaborative has become a staunch representation of Sonoma County values, coalescing with local and tribal governments, foundations, businesses, and individuals to stand up on behalf of our immigrant community to say, "We recognize the critical role you play in our community and we stand with you."

In eight years, we have served over 3000 clients (both individuals and families) with legal and strategic supportive services. The Collaborative has created an equity-driven model for collaborative community response. By focusing organizational resources on the specific needs of underserved immigrant populations, critical service gaps can continue to be identified and addressed. The City Council of Santa Rosa remains a key financial and strategic partner in this effort. Your continued financial assistance helps our immigrant communities confront the legal threats of the immigration system and family separation, understand new rights and opportunities, access social services, and overcome persistent social inequities.

The following resolution of The Board of Supervisors in 2021 reflects the true understanding of local government, the contributions and obstacles faced by the local immigrant community, and their need for assistance.

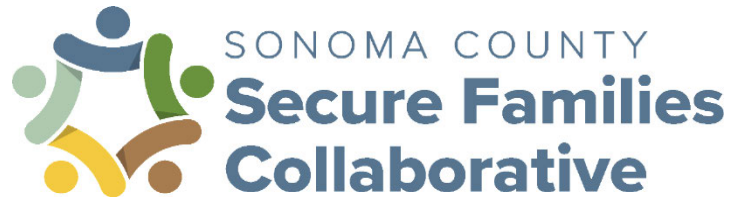
"The County recognizes that the diversity of backgrounds, perspectives, and experiences of undocumented immigrants contribute to the cultural richness and economic wellness of our nation and communities, and the legal status of undocumented immigrants currently restricts many aspects of their lives, including employment options and access to certain safety net programs. The County is supportive of all residents having the right to pursue a dignified life with meaningful employment opportunities and access to community safety nets including disaster relief aid."

"Current immigration law does not provide a clear pathway to citizenship for most undocumented immigrants in this county. Without a path to citizenship, community members continue to be faced with

hardships including but not limited to barriers in securing safe and dignified housing and employment, increased vulnerability during times of disaster, lack of access to healthcare, and facing the constant threat of deportation and family separation.”

The Secure Families Collaborative appreciates the ongoing support of the City Council of Santa Rosa. It enables the organization to maintain its strength and ability to meet the expanding needs of local immigrant communities that were so clearly defined in the Board's Resolution above.

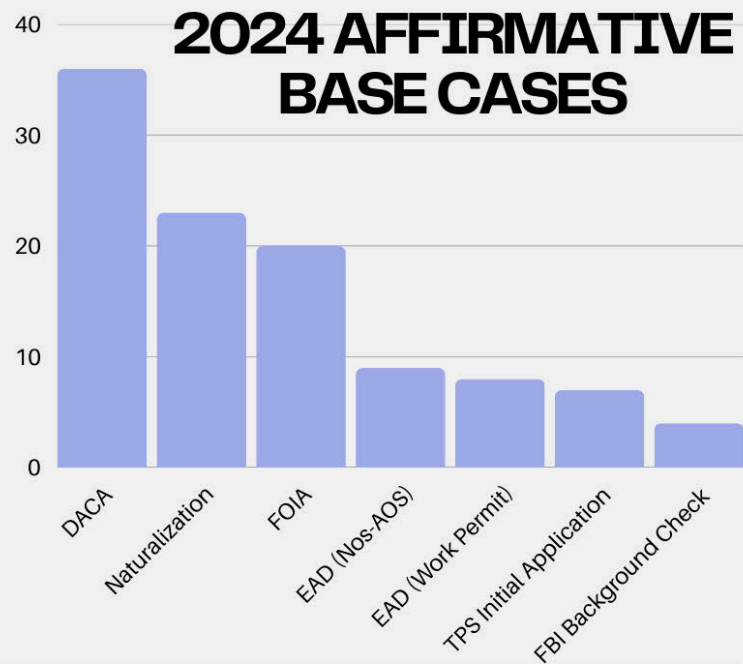

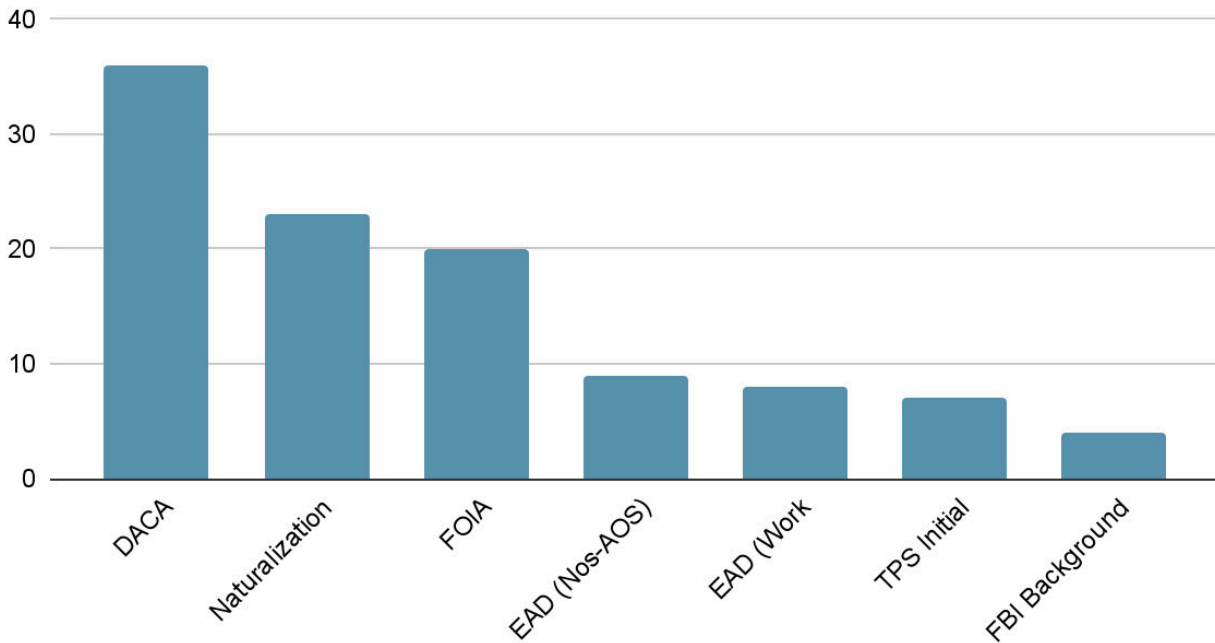

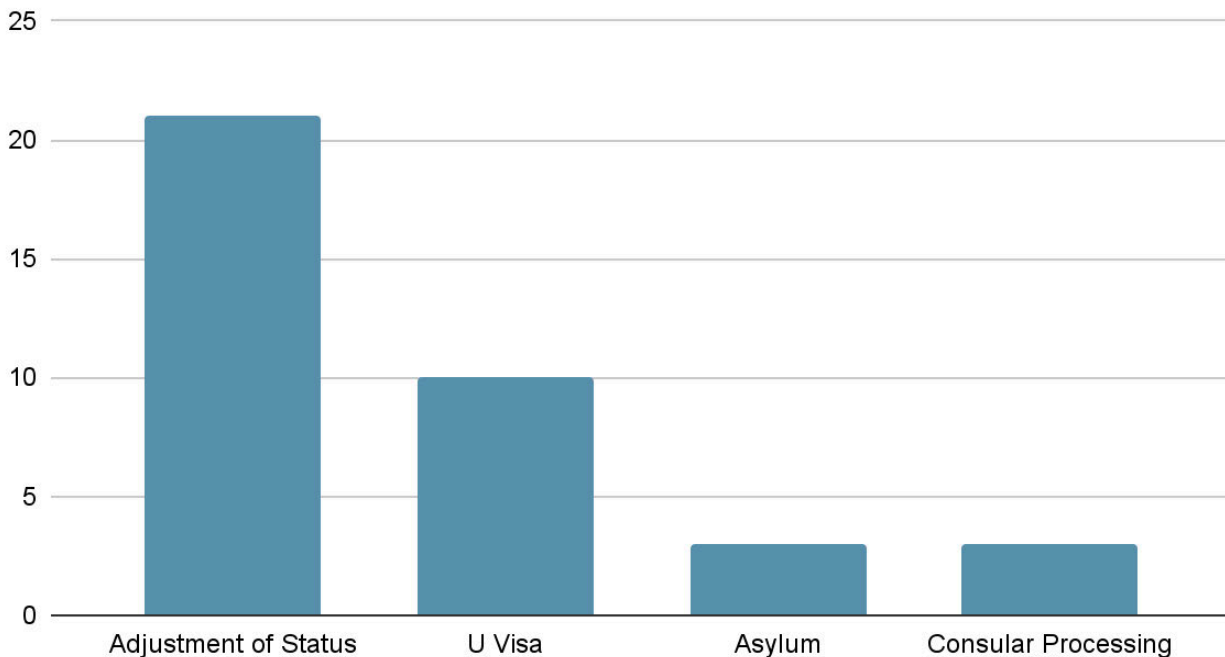

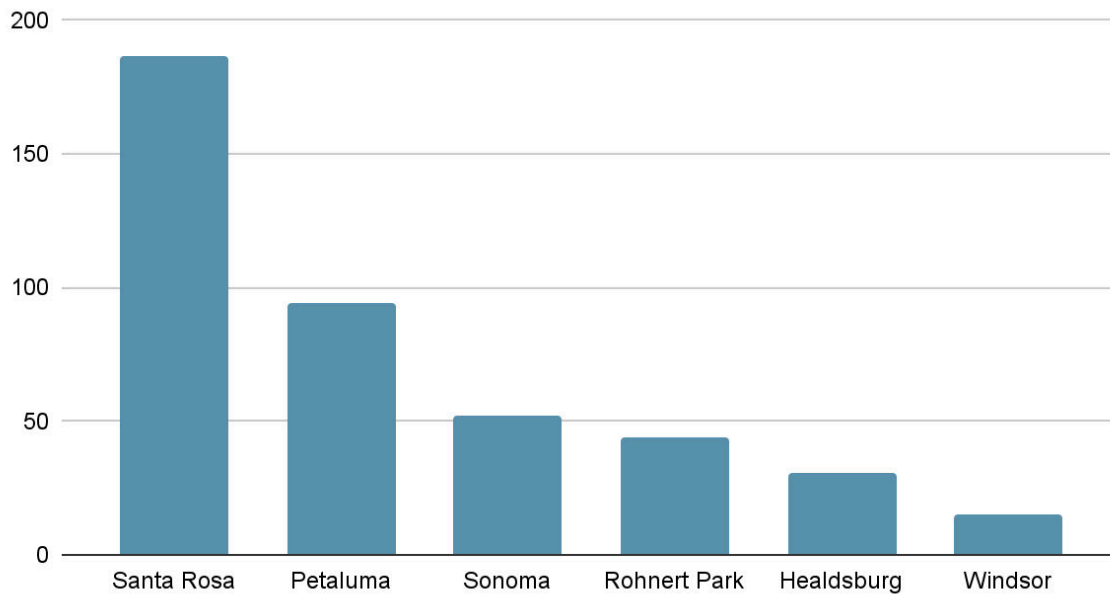

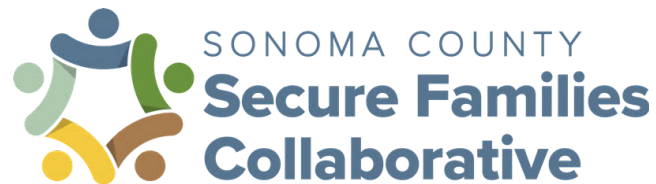

Re: Recommendations for the Enhanced Infrastructure Financing District (EIFD) Draft Infrastructure Financing Plan (IFP)

--

The DAO's support of the EIFD is based on the belief that this funding mechanism is an ideal vehicle to create substantial economic impact *within* the district. Including a potential mix of housing, catalyst development projects, and placemaking infrastructure investments that are at a scale to increase foot traffic, development investment, and vitality within the district. We support honing in on priorities that will have a substantial impact by directly increasing property values and tax revenues as well as business revenue and sales tax revenue. It is paramount that the investments are aligned within the district itself, and benefit both new and existing properties.

At the April 23 DAO Board Meeting, the board discussed the current draft IFP and made the following recommendations for the Public Financing Authority to consider including in the next draft:

1. The DAO brought forward and supported the concept of an EIFD as a mechanism for providing much needed funding for Downtown infrastructure and placemaking and believes that should remain a central component of the IFP. A minimum of 50% of the funds generated should support Downtown infrastructure and placemaking, not directly tied to a catalyst project.
2. Since both affordable housing and a catalyst project are dependent on outside partners as well as additional criteria to come to fruition, there should be flexibility in fund allocation, with a maximum amount of 50% of funding being allocated. Additionally, both a catalyst project and affordable housing projects within the EIFD boundaries would require and rely on enhanced infrastructure and placemaking in the Downtown.

3. Any catalyst project should be in, or immediately adjacent to the EIFD, with easy pedestrian access to Downtown businesses and properties within the EIFD boundaries.

We look forward to continued discussions about the EIFD and appreciate the work of the staff and elected officials who are working to bring this concept to Santa Rosa.

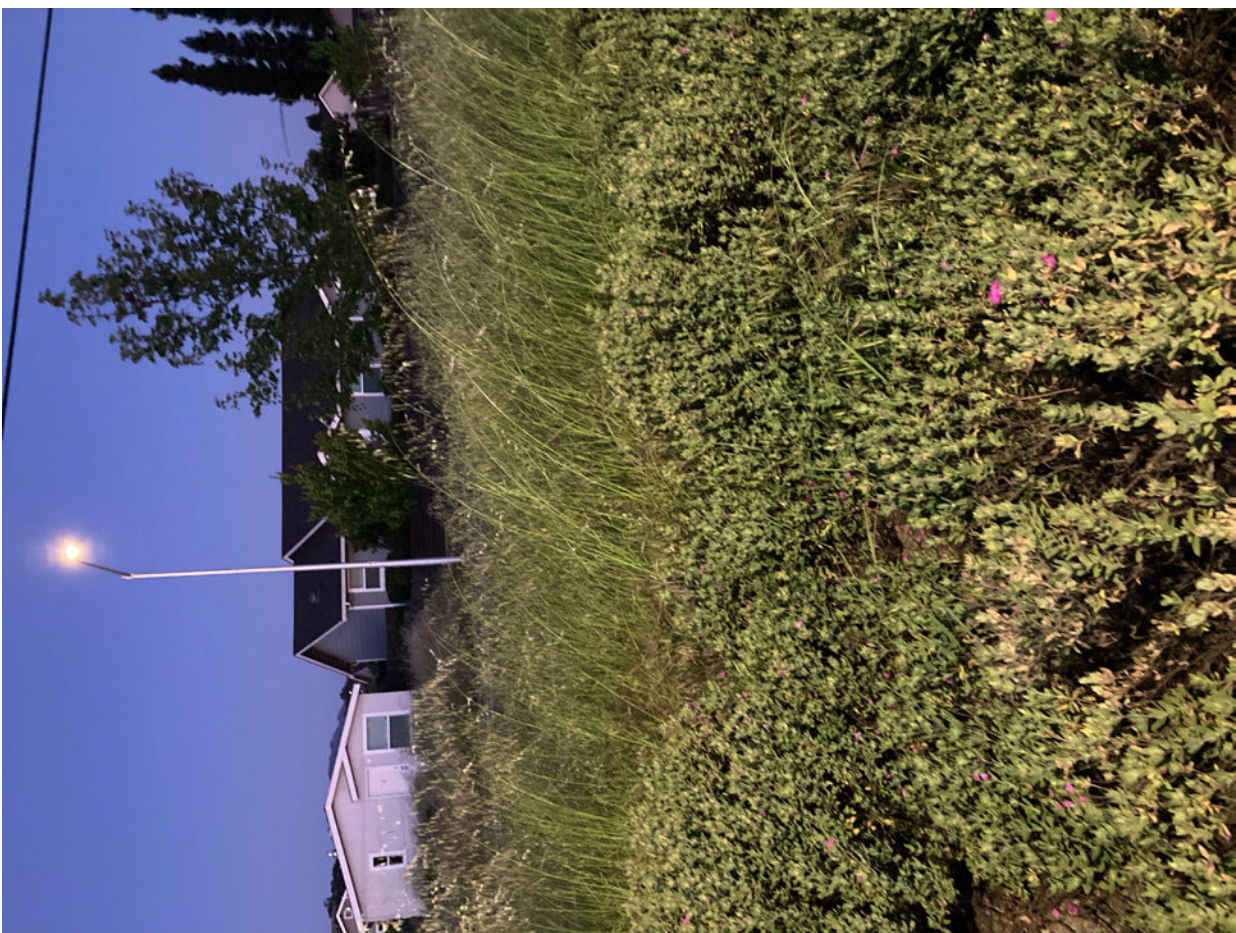

My name is Jenna Cresta, and I'm a former law enforcement officer. I served with pride and dedication, and I understand firsthand the sacrifices officers and their families make every day to serve their communities. I'm speaking to you today not only as a former officer, but as a wife, a mother of three, and someone deeply impacted by the proposed budget cuts to the Santa Rosa Police Department, with my wife, Kelly Cresta, possibly facing demotion.

Several years ago, I served in San Jose, where I had every intention of building my career. But when budget cuts were implemented there, my salary was drastically reduced. Along with many of my colleagues, I was forced to make the heartbreaking decision to leave. It wasn't just a job I walked away from—it was a life I had built, and a promise I had made to my community.

My wife, a dedicated officer herself, left the Hayward Police Department for the opportunities the city of Santa Rosa promised. My name is Heather Chagnon Gruenbaum, a 20 year resident of Santa Rosa and a local business owner, as well as the Vice President of the Montgomery Education Foundation.

I am writing to implore you to fund and reinstate the Santa Rosa City Schools SRO program. My two children are students of Montgomery High School. We moved to Santa Rosa because of the quality of life; to raise our children in safe schools. I juxtapose that basic goal with the abject horror of trying to communicate with my daughter on lockdown at Montgomery High School during the 2023 stabbing tragedy, not knowing if she was safe. Is loss of life in our schools the new reality we accept for our Santa Rosa families?

Dear City Council Members,

I am writing to address the proposed budget cuts affecting our police department, particularly the consideration of eliminating the lieutenant position. I want to be clear: this move is ill-advised and detrimental to our community's safety and well-being.

SRPD management is dangerously understaffed based on our size and Santa Rosa's population. We are at the bottom of **all** comparable agencies. Livermore PD and others, with **half** the population and **half** the number of sworn officers, have nearly as many lieutenants as us. Roseville PD with **over 30,000 less** population and **over 50 fewer** sworn officers currently has **more** lieutenants than us, and Hayward PD, our most comparable in size and population has **10 lieutenants** to our current 7.

Reducing leadership within our force compromises our ability to respond effectively during critical incidents and undermines the trust we have established with community members. A reduction at the lieutenant rank reduces oversight and will limit this agency's ability to swiftly and properly respond to critical incidents, thereby creating a public and officer safety risk, as well as exposing the City to extreme financial liability.

I urge you to reconsider this approach and focus instead on strategies that preserve

essential staffing while addressing budgetary concerns. Our community deserves a fully functioning police department with adequate leadership to ensure public safety and support for our officers.
