About SCFD

- "All Risk" Fire District
- SCFD responds will respond to over 40,000 incidents, such as fire, medical and other emergencies.
- Provides EMS care across more than 425 square miles of Sonoma County
- SCFD was established in April 2019 after the consolidation of several fire districts (Windsor Fire Protection District, Rincon Valley Fire District, Bennett Valley Fire District, and Mountain Volunteer Fire Department.
- July 2020, three other fire districts joined SCFD
 (Russian River Fire Protection District, Forestville Fire Protection District, and Bodega Bay Fire Protection District).

- CAAS Accredited since 2007, First CAAS accredited ambulance Service in Northern CA

- 150,000 Annual Calls for Service




What is SCFD-EMS

- In 2023, SCFD, with Medic as its subcontractor, bid and was awarded the EOA contract that started on Jan 15, 2024.
- SCFD is the contract holder with Sonoma
 County; Medic is the subcontractor to SCFD.
- We are Partners in Care; and have integrated leadership teams to administer and operate the ambulance System in EOA-1 as SCFD-EMS

System Compliance

- SCFD and Sonoma County Health and Human services entered into an agreement for services, that enforces standards and compliance for the ambulance services agreement.
- REDCOM is the dispatch center for all SCFD-EMS resources
- All compliance related data is tracked and measured using real-time CAD data directly from REDCOM, which is connected via a data link to FirstWatch's Online Compliance Utility (OCU).

SCFD-EMS System Enhancement and Offerings

- Deploying a weekly Peak of 21 Ambulances at the highest historical demands
- AMBUBUS That can transport up to 24 patients at once, with ALS/BLS treatment capability
- · (4) 4x4 Ambulances
- ATV Ambulance
- Special Operations
- Mobile Command Center
- Dedicated Type 3 Bariatric Ambulance, that has patient capabilities of up 1400 lbs, with specialized gurney and winch system.
- · Onboarded over 140+ employees in 4 months leading up to contact start
- 25 New Type III Ambulances with Auto-Loader Stryker Power Gurneys





SCFD-EMS System Enhancement and Offerings (Cont'd)

- New 15,000 Sq ft Operations Center located at 1269 Corporate Center Parkway, with more Comfort Stations located strategically throughout the County (Santa Rosa Urban Based Locations below:)

 - · SCFD Station 4 207 Todd Rd, Santa Rosa
 - SCFD Station 5 91 Middle Rincon Rd, Santa Rosa
 - · 6572 Oakmont Dr
- New 4 Year Labor Agreement, making our EMS workforce one of the highest paid in Nation
- · Focus on building a sustainable, local EMS workforce dedicated to Sonoma County
 - Great Success in last 12 months, Fully Staffed with EMTs and Paramedics, with wait list. Over 30 EMTs in Paramedic School, 10 on Scholarship



SCFD-EMS System Enhancement and Offerings (Cont'd)

- First Response ALS Agreement with Santa Rosa, ensuring equitable reimbursement for 12 Engines responding in EMS First Response capacity, while also promoting increased collaboration in the field and administration between SCFD-EMS and SRFD.
- First Response BLS Agreements with Gold Ridge Fire Protection and Rancho Adobe Fire Protection District, enhancing the level and responsibility of first response delivery in Sonoma County.



SCFD System Enhancement and Offerings (Cont'd)

- Working with our other Fire and First Response partners to deploy LUCAS 3

 Automated CPR Devices to ensure the availability of high-quality CPR. 18 Units to be placed over next 12 months.
- In 2025, SCFD-EMS is upgrading to the Stryker LifePack 35 Monitors. This is one of newest and most modern life-saving equipment to come to the EMS market. We are honored to be one of the first agencies in Northern California to implement.
