New Railroad Square has received certain land use entitlements, environmental clearances and/or financial pledges from local, state and federal agencies, and private entities. However, real estate and financial markets continue to be weak for new commercial and new market-rate residential construction amid other challenges to the financial feasibility of the project. The State has revised the Proposition 1C Grant program to allow a grant recipient to modify its project from a multi-phase project to a stand-alone project with a commensurate reduction in the grant award.

13. REPORT ITEMS

13.1 REPORT – SONOMA COUNTY WATER AGENCY 2013/14 WATER TRANSMISSION **BUDGET AND WATER RATE INCREASE**

BACKGROUND: Sonoma County Water Agency (SCWA) staff presented the 2013/14 Water Transmission System budget to the Water Advisory Committee (WAC) on February 4, 2013. Based on budget documents provided by SCWA, the proposed wholesale water rate for the City of Santa Rosa will increase 4.95% or from \$672.03 per acre foot to \$705.29 per acre foot. This will translate into a 2.1% "pass-through" to Santa Rosa's water customers beginning July 1.

SCWA will present the 2013/14 water transmission system budget for the Council's consideration after which time the Council may make a recommendation to the City's WAC representative, Council Member Robin Swinth, on whether or not to recommend approval of the proposed 2013/14 SCWA water transmission budget.

On April 1, 2013 the WAC is scheduled to vote on whether or not to recommend approval of the proposed 2013/14 SCWA water transmission budget and water rate increase request to the SCWA Board of Directors.

RECOMMENDATION: It is recommended by the Department of Utilities and the Board of Public Utilities that Council, by motion, authorize Santa Rosa's WAC representative to vote in favor of approving the proposed 2013/14 SCWA water transmission budget and water rate increase request.

Glen Wright, Deputy Director Engineering Services, Michael Thompson, Assistant General Manager for Sonoma County Water Agency, and Lynne Rosselli, Finance and Accounting Manager for Sonoma County Water Agency, provided the staff report and responded to questions from Council members.

PUBLIC COMMENT

Peter Tscherneff spoke in favor of reducing resident utility rates and increasing winery utility rates and other topics.

Stephen Fuller-Rowell spoke in favor of increasing the differences between the rate tiers.

Following Council discussion, it was MOVED by Council Member Ours, seconded by Council Member, and carried 5-2 (Council Members Combs and Wysocky voting no) to authorize Council Member Swinth as Santa Rosa's representative on the Water Advisory Committee to vote in favor of approving the proposed 2013/14 Sonoma County Water Agency water transmission budget and water rate increase request.

Mayor Bartley recessed the meeting at 6:46 p.m. and reconvened the meeting at 6:55 p.m. With Council's concurrence Mayor Bartley reordered the agenda to consider Public Hearing Item 14.1 at this time.

14. PUBLIC HEARINGS

14.1 PUBLIC HEARING – RESOLUTION AUTHORIZING WEED AND RUBBISH ABATEMENT BY THE CITY OF SANTA ROSA FIRE DEPARTMENT

BACKGROUND: On February 12, 2013, Council declared, by resolution, weeds and rubbish as a public nuisance. The second procedure is to publish a notice of a public hearing, at which time a person or persons may voice an objection to the Weed and Rubbish Abatement Program. After hearing any or all protests, the Council, by resolution, may grant or overrule any protest and authorizes the Fire Department to abate the nuisances.

RECOMMENDATION: It is recommended by the Fire Department that the Council, by resolution, grant or over rule any protests and authorize the Fire Department to abate the nuisances.

Toby Rey, Fire Inspector I, provided the staff report.

PUBLIC HEARING

Mayor Bartley opened the public hearing at 6:57 p.m. Seeing no one wishing to speak, Mayor Bartley closed the public hearing at 6:57 p.m.

It was **MOVED** by Council Member Combs, seconded by Council Member Olivares, and carried unanimously to waive reading of the text and adopt:

RESOLUTION NO. <u>28251</u> ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA OVERRULING PROTESTS AND AUTHORIZING ABATEMENT OF WEEDS OR RUBBISH UPON OR IN FRONT OF CERTAIN PROPERTIES WITHIN THE CITY OF SANTA ROSA AS A PUBLIC NUISANCE

13.2 REPORT – MEASURE O BASELINE FUNDING RECOMMENDATION

BACKGROUND: In 2004, Ordinance 3680 added Chapter 3-26 to the Santa Rosa City Code establishing a special transactions and use tax, known as Measure O, which increased sales tax by a quarter cent to fund specific Police, Fire, and Gang Prevention/Intervention programs. The ordinance has a provision setting a baseline funding level in the General Fund for each of the three aforementioned programs. The baseline was established as the Fiscal Year (FY) 2004/05 budget for these programs adjusted annually by the Consumer Price Index (CPI). The Measure O ordinance also provides the ability to operate below the specific baseline requirements with six affirmative votes by the City Council. The Police General Fund budget is projected to be approximately \$2M under baseline for FY 2013/14. Beginning in FY 2011/12, the Police Department General Fund budget baseline has been restored by approximately \$2 million. While some of the increases to the Police budget resulted from increases in the General Fund revenue base, a significant amount came from budget reductions to other, non-Measure O-related General Fund budgets. These reductions consisted of drastic cuts to services and supplies as well as the loss of three positions since FY 2011/12. The purpose of this item is to call attention to the fact that the projected Police Department budget will continue to be below baseline for FY 2013/14, and provide a mechanism for the City Council to approve, with six affirmative votes, a budget below targeted baseline levels at the outset of the budget process instead of at the budget hearings.

RECOMMENDATION: It is recommended by the City Manager's Office and the Finance Department that the City Council, by resolution and with six affirmative votes, approve the Police Department General Fund budget baseline funding for FY 2013-14 at an amount not to exceed \$1.1 million below the Measure O target baseline.

Alan Alton, Administrative Services Officer, provided the staff report and responded to questions from Council members.

PUBLIC COMMENT

<u>Anne Seeley</u>, Concerned Citizens for Santa Rosa, spoke in favor of the staff recommendation.

Following Council discussion, it was **MOVED** by Council Member Swinth and seconded by Vice Mayor Carlstrom to waive reading of the text and adopt the following resolution, with the final paragraph amended to delete "in an amount not to exceed \$1.1 million below such baseline":

RESOLUTION ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING LOWER LEVELS OF FUNDING FOR CERTAIN POLICE DEPARTMENT PURPOSES AND USES

The motion failed 5-2 (Council Members Combs and Wysocky voting no).

Following further Council discussion, it was **MOVED** by Council Member Combs and seconded by Council Member Wysocky to authorize the City Manager to go below baseline in an amount not to exceed \$1.6 million. The motion failed 3-4 (Mayor Bartley, Council Members Olivares, Ours and Swinth voting no).

Following further Council discussion, it was **MOVED** by Council Member Swinth, seconded by Council Member Combs, and carried unanimously to approve the Police Department General Fund baseline funding in a range not to exceed \$1.1 million to \$1.6 million below the Measure O target baseline and direct staff to provide further details at a future Council meeting regarding services provided at \$1.1 million, \$1.35 million and \$1.6 million. The motion carried unanimously and the following resolution was adopted, with the final paragraph amended to read, "NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa for FY 2013/14 approves general fund funding for Police Department purposes and uses at levels lower than those in the approved budget for FY 2004/05, as adjusted annually pursuant to Section 3-26.120 (G) of the City Code in a range between \$1.1 million and \$1.6 million below such baseline":

RESOLUTION NO. <u>28250</u> ENTITLED: RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING LOWER LEVELS OF FUNDING FOR CERTAIN POLICE DEPARTMENT PURPOSES AND USES
