ISSUE(S)

Should the City Council adopt a motion awarding a construction contract in the total amount of \$662,902.75 to the lowest responsible bidder, Ghilotti Bros., Inc., of San Rafael, CA, and establish a total contract amount of \$729,193.02 (the original contract amount plus a 10% contingency)?



COUNCIL GOALS AND STRATEGIES

This project will improve mobility near commercial areas, which is essential to economic vitality.

BACKGROUND

The project will improve traffic circulation. Right turn lanes will be constructed from southbound Mendocino Avenue onto westbound Bicentennial Way and from eastbound Bicentennial Way onto southbound Mendocino Avenue.

ANALYSIS

- 1. The project was advertised on October 29, 2012, and bids were received on December 5, 2012. A total of six bids were received, ranging from \$662,902.75 to \$829,945.50. The low bid was approximately 2% below the Engineer's Estimate.
- 2. The low bidder, Ghilotti Bros., Inc., possesses a valid contractor's license of the required class, as verified by the Contractor's State License Board.
- 3. The contract agreement has been reviewed and approved by the City Attorney.
- 4. Construction is anticipated to begin in March 2013. The length of the contract is 60 working days.

5. The Public Participation Plan has been approved by the Transportation and Public Works Marketing and Outreach Coordinator. City staff has coordinated with Kaiser Permanente in preparation for this project.

RECOMMENDATION

This motion, recommended by the Transportation and Public Works Department, awards construction Contract No.C00743, Bicentennial Way and Mendocino Avenue Traffic Signal Modification in the total amount of \$662,902.75 to the lowest responsible bidder, Ghilotti Bros., Inc. of San Rafael, CA, and establishes a total contract amount of \$729,193.02 (the original contract amount plus a 10% contingency). Funding for this project has been appropriated to JL Key 17055. The sources of funds are Community Facilities District No. 1, Capital Facilities Fee Fund and Gas Tax. No City General Fund money is included in this project.


