RESOLUTION OF THE BOARD OF PUBLIC UTILITIES RECOMMNEDING CITY COUNCIL RE-ADOPT AS AMENDED COUNCIL POLICY NO. 200-20, "PROVISION OF PRIORITY WATER SERVICE TO RESIDENTIAL DEVELOPMENTS WITH AFFORDABLE HOUSING UNITS" AND COUNCIL POLICY NO. 200-21, "PROVISION OF PRIORITY SEWER SERVICE TO RESIDENTIAL DEVELOPMENTS WITH AFFORDABLE HOUSING UNITS"

WHEREAS, the California legislature has declared the lack of affordable housing is a matter of vital statewide importance; and

WHEREAS, the City of Santa Rosa is committed to the fair and equitable provision of water and sewer services to persons and entities within its service area, in conformance with state law and City policies; and

WHEREAS, Government Code Section 65589.7 enhances the priority granted to lower-income housing by requiring that public agencies that provide water or sewer services shall adopt written policies and procedures with specific objective standards for providing priority service to residential developments with lower income housing; and

WHEREAS, Government Code Section 65589.7 requires the review of these policies every 5 years; and

WHEREAS, the Council Policy No. 200-20 and 200-21 require the review and adoption or re-adoption at least once every 5 years after July 1, 2006; and

WHEREAS, re-adoption of these policies regarding provision of priority water and sewer service to residential developments with affordable housing will allow the City of Santa Rosa to remain in compliance with Government Code 65589.7; and

WHEREAS, the Water Department and Planning & Economic Development Department staff have reviewed these policies and recommend re-adoption with small text changes to be consistent with the terminology used in the City's 2035 General Plan.

NOW, THEREFORE, BE IT RESOLVED that the Board of Public Utilities recommends that the Council of the City of Santa Rosa re-adopt as amended Council Policy No. 200-20, "Provision of Water Service to Residential Developments with Affordable Housing Units" attached hereto as Exhibit "A" and Council Policy No. 200-21 "Provision of Sewer Service to Residential Developments with Affordable Housing Units" attached hereto as Exhibit "B."
