NOTICE OF PUBLIC HEARING



ADOPTION OF THE ANIMAL SERVICES FEE SCHEDULE

Notice is hereby given that a public hearing will be conducted by the City Council on **Tuesday, July 10, 2018, at or after 5:00 p.m.**, in the City Council Chamber, City Hall, 100 Santa Rosa Avenue, Santa Rosa. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on proposed increases on Animal Services fees, in accordance with the proposed fee schedule below:

- Impound - Cat Altered – The fee increase from \$21.00 to \$22.00 will result in \$50.00 in additional revenue and 14.9 percent cost recovery.
- Impound - Cat Unaltered – The fee increase from \$26.00 to \$27.00 will result in \$6.00 in additional revenue and 18.3 percent cost recovery.
- Impound - Dog First Impound - Licensed – The fee increase from \$63.00 to \$65.00 will result in \$376.00 in additional revenue and 44.1 percent cost recovery.
- Impound - Dog First Impound – Not Licensed – The fee increase from \$79.00 to \$81.00 will result in \$834.00 in additional revenue and 55.0 percent cost recovery.
- Impound - Dog Second Impound - Licensed – The fee increase from \$132.00 to \$136.00 will result in \$232.00 in additional revenue and 92.3 percent cost recovery.
- Impound - Large Livestock – The fee increase from \$57.00 to \$59.00 will result in \$12.00 in additional revenue and 40.0 percent cost recovery.
- Impound - Small Livestock – The fee increase from \$26.00 to \$27.00 will result in \$7.00 in additional revenue and 18.3 percent cost recovery.
- Impound – Rabies Quarantine – The fee increase from \$96.00 to \$99.00 will result in \$108.00 in additional revenue and 67.2 percent cost recovery.
- Board Per Day - Dog – The fee increase from \$21.00 to \$22.00 will result in \$444.00 in additional revenue and 59.8 percent cost recovery.
- Board Per Day - Cat – The fee increase from \$21.00 to \$22.00 will result in \$41.00 in additional revenue and 59.8 percent cost recovery.
- Board Per Day - Livestock – The fee increase from \$21.00 to \$22.00 will result in \$7.00 in additional revenue and 59.8 percent cost recovery.
- Board Per Day - Rabies Quarantine – The fee increase from \$26.00 to \$27.00 will result in \$34.00 in additional revenue and 73.4 percent cost recovery.

Kennel/Pet Shop License Fees

- Kennel License - Commercial Kennel – The fee increase from \$195.00 to \$201.00 will result in \$186.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Kennel License - Hobby Kennel – The fee increase from \$195.00 to \$201.00 will result in \$6.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.

- Kennel License - Pet Fancier Cat Altered – The fee increase from \$20.00 to \$21.00 will result in \$1.00 additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Kennel License - Pet Fancier Cat Unaltered – The fee increase from \$40.00 to \$41.00 will result in no additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Kennel License - Pet Fancier Dog Altered – The fee increase from \$40.00 to \$41.00 will result in \$17 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Kennel License - Pet Fancier Dog Unaltered – The fee increase from \$81.00 to \$83.00 will result in \$50.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Kennel License - Pet Shop – The fee increase from \$195.00 to \$201.00 will result in \$6.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.

Other Fees

- Animal Rendering Service – The fee increase from \$69.00 to \$71.00 will result in \$230.00 in additional revenue and 95.7 percent cost recovery.
- Vicious Dog Registration – The fee increase from \$345.00 to \$355.00 will result in \$391.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Potentially Dangerous Dog Registration – The fee increase from \$138.00 to \$142.00 will result in \$384.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Rabies Quarantine - Home – The fee increase from \$68.00 to \$70.00 will result in \$416.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Owner Surrender Fee, Non-Contract City – The fee increase from 110.00 to \$114.00 will result in \$28.00 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Owner Surrender Fee (Dog, Cat, Litters, Livestock, Birds) – The fee increase from \$55.00 to \$57.00 will result in \$744 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Vaccination Bordatella, DHLPP, FVRCP – The fee increase from \$24 to \$25 will result in \$736 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Vaccination/Testing FELV/FIV, Heartworm - The fee increase from \$24 to \$25 will result in \$12 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
- Vaccination/Rabies - The fee increase from \$24 to \$25 will result in \$71 in additional revenue. The requested increase recovers the 3.0 percent cost of living increase.
