

RESOLUTION NO. RES-2021-028

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH CALLANDER ASSOCIATES LANDSCAPE ARCHITECTURE, INC. TO PROVIDE A SYSTEMWIDE PARKS CONDITION ASSESSMENT, DEFERRED MAINTENANCE ANALYSIS, AND PROJECT PRIORITIZATION FOR THE CITY'S PARK SYSTEM

WHEREAS, Sonoma County placed a one-eighth of one percent sales tax measure, Measure M, the Parks for All Measure, on the 2018 voters' ballot; and

WHEREAS, City Council supported Measure M by resolution, RES-2018-177, on October 2, 2018; and

WHEREAS, voters approved Measure M by 72.6 percent on November 6, 2018; and

WHEREAS, Measure M provides an estimated \$1.9 million in annual revenue to the City of Santa Rosa for Recreation and Parks services; and

WHEREAS, City Council approved an Initial and Long-Term Priority Plan to determine priority use of the portion of Sonoma County Measure M funds allocated to the City of Santa Rosa by resolution, RES-2019-142, on September 10, 2019, including consultant recommendations for deferred maintenance and overall recommendations for parks; and

WHEREAS, proposals were invited for performance of a systemwide parks condition assessment, deferred maintenance analysis, and project prioritization for the City of Santa Rosa's Park System; and

WHEREAS, three proposals were received on October 22, 2020, and reviewed in accordance with City policy; and

WHEREAS, the scope of work associated with the Professional Services Agreement provides a systemwide park condition assessment, deferred maintenance analysis, and project prioritization and is integral to determining how the City should prioritize its share of Measure M sales tax revenues; and

WHEREAS, funding for these services is available from Measure M sales tax revenues in Fund 09774 – Parks Condition Assessment.
