My name is Jen Miller. I am a resident of Santa Rosa and I am jewish.

I urge you to put a ceasefire resolution on the agenda and pass it as soon as possible. I urge you to listen to your community who has spoken at council night after night (and emailed) with overwhelming support for a ceasefire resolution.

The humanitarian emergency in Gaza is overwhelming- children are dying from lack of food. People are eating animal feed to survive. But, I believe you already know about the malnutrition, starvation, war crimes, and death toll statistics.

This is a local issue because our very own tax dollars are sent to the Israeli military who is waging collective punishment and mass starvation on innocent people.

This is a local issue because palestinian and jewish community members of Santa Rosa are in pain, and look to you, our representatives, to hear our voices and support justice and safety and to stop the killing. Dear Mayor and Councilmembers,

I am writing regarding the issue of the Council agendizing a Gaza ceasefire resolution. I am in favor of such a resolution. I've been to a few of your meetings and it's clear that the issues have been well presented to you, both pro and con. Yet, at this point you continue to refuse to agendize the matter. That is a safe position, allowing you to duck the matter without expressing your opinion on what many, including myself, believe is a genocide happening with US support, dollars and weapons.

One of the arguments for not agendizing the issue is that it is beyond the purview of local government. But in many aspects, this war will have a huge issue on local politics. Besides the impact on our society as a whole, I'm referring to the role that AIPAC, the American Israel Public Affairs Committee and its affiliated political action committees United Democracy Project (UDP) and Democratic Majority for Israel (DMFI) are playing in our congressional elections.

It's complicated, but please stick with me here.

AIPAC, as I'm sure you know, is dedicated to support for Israel and Zionism. In 2022 they endorsed 365 candidates, Democrats and Republicans, and contributed over \$50 million through direct contributions and independent expenditure accounts. Their sole litmus test was whether the candidate supported Israel. They ended up endorsing candidates who were anti-choice, candidates who said the 2020 presidential election was stolen, and candidates who supported the January 6 insurrection. AIPAC didn't care about their stance on these issues; they only cared about their views on Israel. Their efforts played a major role in the Republican victory in the House and moving the country to right on a host of issues.

Their initial salvo for this year is in Katie Porter's congressional district, CA 47, where AIPAC, UDP and DMFI have spent over \$600,000, and when it's all done, are projected to spend a million dollars to defeat Dave Min. And Min isn't even a big critic of Israel. He's just not as rah-rah as his opponent, Joanna Weiss.

AIPAC and the leaders of the Israeli government are joined at the hip. As Israel moves further to the right, and focuses even more on crushing Palestinians, AIPAC will promote more pro-Israel candidates in the US, and our country will also be pushed to the right. MAGA type politics will get stronger in both countries. That is part of the goal.

And when people such as yourselves decide to run for higher office, AIPAC will be in your face, threatening you with dumping big dollars on behalf of your opponent, unless you toe the line in support of Israel. I suspect that many, if not most of you, will not welcome this involvement in California politics. But it is here.

In order to defeat MAGA politics in this country, we have to move the powers-that-be in Washington away from their blind loyalty to Israel. The two phenomena are connected. A just peace in Israel will help us create a more just society in the US. The first step in creating that just peace is to help build the movement for a ceasefire.

Please act now.

My name is Gillan Stewart, and I am a Santa Rosa resident living in District 5. I am writing today to urge the council to pass a ceasefire resolution for the people living in Occupied Palestine. The citizens of Gaza are facing a humanitarian crisis, and while some members of the council may believe a ceasefire resolution on the local level is not an appropriate or necessary step to take, I can assure you that local voters will be considering this issue when it comes time to honor our values at the voting booth. Months of bombardment at the hands of Israeli Occupation Forces have displaced millions and murdered thousands, forcing many Palestinians into the southernmost point of Rafah, where they now face the threat of a ground invasion and mass starvation. Palestinians are being denied their basic rights to food, water, and to not being collectively punished for a war they did not start. I attended last week's city council meeting, and while those opposed to a ceasefire may wish to believe those in favor of such a resolution are in the minority, 33 of the 36 people who spoke during public comment were IN FAVOR of passing a ceasefire resolution.

The inaction of the city council has gone on long enough, but it is not too late to make the right choice and put a ceasefire resolution on the agenda. Bringing it to a vote, even if it does not pass, will at least honestly let your constituents know where their elected representative stands on the decades long war against the Palestinian people.

Dear City Council,

I am one of many Jewish constituents urging you again to please agendaize a ceasefire resolution.

I have gone through the City Council meeting archives to tally up what the community response has been to this request since Dec 12, 2023, when the community started its request for this action.

I went through the videos and the emails that were attached to the agendas. Here is what I found:

In all, the average response for **in-person** comments is **91.2% in favor** of the Council adopting a ceasefire resolution.
For **email** responses, the average is **83% in favor** of the demand for the resolution.

One piece of data I couldn't collect is how many of your constituents that are speaking up in favor of the resolution are Jewish. I know from organizing in the community that many of the people are, and in watching the council archives and reading the emails, I know some of these people personally who are Jewish & who aren't mentioning it in their comments (I think they are simply forgetting to). So I want to add that, anecdotally, I would average about 1/3 of the people advocating for the resolution are Jewish.

As the atrocities worsen each passing day, I ask you all- how much more horrific does this situation need to get? How much more broad do we need to be in our coalition for this to matter to you? We already are a coalition of Jews, Palestinians, Arabs, Muslims, Christians, educators, parents, students, White, Black, Asian, Latin@, working class, business owners, retirees, elders, youth, etc. How much more broad do we have to be? If the synagogues are not on board, I fear they never will be. We can't wait for their approval- our resolution includes condemning all forms of violence & hatred and advocating for the release of all hostages, which has been voiced as being necessary for some folks in the opposition in order for them to support it. Many of the opponents haven't even read the resolution. It is clear to all the world that what is happening in Gaza & the West Bank are the gravest of human rights violations.

If the synagogues are still not on board then I'm afraid that's their problem and that is a major reason why many of us Jews are not congregants of the synagogues. Many of us have not felt at home in these synagogues long before Oct 7 because of their blind fealty to Israel,

despite its long history of documented human rights violations.

We cannot wait any longer. Gaza is starving to death.

Dear city council members,

As a voting resident of Santa Rosa, I am writing, again, to implore you to listen and act upon the issues your constituents bring to our city council meetings.

Since the last meeting, when our council members elected not to take any action to stand against genocide, another war crime from Israeli's playbook has been widely document. In case anyone needs a refresher:

The Rome Statute of the International Criminal Court provides that intentionally starving civilians by “depriving them of objects indispensable to their survival, including willfully impeding relief supplies” is a war crime.

Rule 53 of the International Humanitarian Law:
