

RESOLUTION NO. RES-2018-210

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE MEMORANDUM OF UNDERSTANDING WITH SONOMA COUNTY JUNIOR COLLEGE DISTRICT AND SCJCD ASSOCIATED STUDENTS FOR THE CITYBUS UNLIMITED ACCESS PASS PROGRAM THROUGH JUNE 30, 2020

WHEREAS, the Sonoma County Junior College District (SCJCD) recognizes the importance of transit services and is thus using revenue generated from the Student Transportation Fee (STF) to enter in to an unlimited transit ridership program with the transit providers within Sonoma County; and

WHEREAS, on September 19, 2017, by Resolution RES-2017-189, the Council of the City of Santa Rosa approved a Memorandum of Understanding (MOU) with the SCJCD and SCJCD Associated Students for a “pilot” unlimited ridership program for Santa Rosa Junior College (SRJC) students for the Fall 2017 semester; and

WHEREAS, on December 19, 2017, by Resolution RES-2017-251, the Council approved Amendment No. 1 to the MOU to extend the “pilot” unlimited ridership program through Spring 2018 semester until June 30, 2018; and

WHEREAS, on June 19, 2018, by Resolution RES-2018-101, the Council approved Amendment No. 2 to the MOU to extend the “pilot” unlimited ridership program through December 31, 2018; and

WHEREAS, the SCJCD would like to enter into a multi-year agreement and make available \$194,000 to the City of Santa Rosa for an unlimited number of student rides from December 31, 2018 through June 30, 2020, with four one-year options to renew.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Santa Rosa approves the Memorandum of Understanding with the Sonoma County Junior College District and SCJCD Associated Students for the CityBus Unlimited Access Pass Program, in substantially the same form as Exhibit A to the Resolution, subject to approval as to form by the City Attorney.
