Three years ago, more than **400 Skyhawk residents** united to **oppose** the proposal to establish a **permanent 24-bed Addiction Services center** in Skyhawk Village—presented misleadingly as a “community services center.” After careful review and a well-attended public hearing on **December 8, 2022**, the Planning Commission **rightly denied** the Minor Use Permit based on overwhelming community opposition and clear incompatibility with our neighborhood.

Three years ago, many residents of our neighborhood signed a petition to block the proposal to establish a permanent 24-bed Addiction Services center in Skyhawk Village. Now Pura Vida Recovery Services is once again trying to persuade the City that this would be a good location for another one of its facilities.

It is our understanding that Pura Vida is an inpatient *and outpatient* facility that treats dual diagnosis disorders, which include substance abuse as well as mental health conditions. While we have no doubt the services provided by this privately-owned company are valuable, the placement of these facilities must be carefully considered by the City. Concentrating a population of recovering addicts and people with mental health concerns at the entrance of a neighborhood with an elementary school less than a mile from the intended location is not ideal. There have to be many other locations in Santa Rosa that are more suitable and would provide the same level of accessibility for the Pura Vida residents.

We are very proud to live in Santa Rosa, which is a model for the rest of the country with its inRESPONSE mental health crisis team. We hope that it will make thoughtful decisions that include all of its residents when being presented with these kinds of proposals.

My name is DJ Phimister and I live near the proposed Detox facility at 5761 Mountain Hawk Dr. I recently saw the sign advising this facility will come before the Planning Commission next Thursday. I was one of the 40 people who spoke out against the facility about three years ago when it was first proposed and denied. I'm surprised it is being resubmitted, as I don't know of any major changes to their first proposal. I'm also somewhat surprised I didn't receive any written notification of the Planning meeting, especially since I spoke out against it three years ago. How long has the City known of the application, and is there some reason we have such short notice on the proposal? Although I believe the facility has admirable goals, it is in the wrong place with insufficient guidelines to hold them accountable. Accountability is only one of many concerns I have about the facility. Their literature implies they are not a medical facility but it was determined three years ago that they do control all medications for their clients. They also say the clients will be mostly off-site during the day and confined to their room in the evening and overnight, however it was determined three years ago that this isn't a locked facility, so the clients can leave anytime they wish. There will be nothing to stop them from going out at 10:00 at night to smoke a cigarette or talk to a friend. Three years ago we were told that people who violate the rules would be terminated from the program, however recidivism is a common occurrence with substance rehab and second chances are standardly part of a program. Enforcement would be left up to the staff on hand and there is nothing to hold them to any kind of standard as to what would constitute a dismissable event or events. Staffing is also a concern. They have listed what their maximum staffing would be, but no indication of what their minimum staffing will be. The numbers for overnight staff were not listed in the paperwork I have seen, so it is plausible they would only have one staff member on site for 24 clients. Regardless, even if they say they are going to have two or more, there is currently nothing to hold them to any staffing requirements. Should this facility be approved, this issue, along with many others should be addressed in a conditional use permit. All of these issues and more should be discussed with the owner and Planning representatives to make sure the Commissioners have a full view of the potential impacts of approving this facility and appropriate concerns are addressed in a conditional use permit. I offered three years ago to participate in such a meeting, but it never happened. Ultimately, we ended up with about 40 people speaking when it came up before the City. Our speaking time was extremely limited and it was not really the best way to address all of the concerns. I am again offering to participate in such a meeting if it can somehow be arranged prior to the meeting next Thursday. Please let me know if you would like a full list of all of my concerns prior to next Thursday. I do have more, but with time so short, I wanted to get something in quickly to try and determine the best way to address my questions & input.

Good morning, David,

Thank you for your email. The public hearing for the Minor Use Permit application at Skyhawk Village has been scheduled in accordance with the City's standard noticing procedures and requirements under [Zoning Code Chapter 20-66](#). Unfortunately, postponing a hearing is not something we typically do by request.

Notices for public hearings are mailed at least 10 days in advance to property owners and residents within the required radius, providing time for the community to submit comments or attend the hearing. [Section 20-66.040](#) states that "hearings shall be held at the date, time, and place described in the public notice" and that the hearing may be continued if continuance is found to be necessary.

Minor Conditional Use Permits are acted on by the Zoning Administrator in a public meeting, and do not require a formal public hearing unless one is requested. The previous proposal was set to go before the Zoning Administrator on October 20, 2022. However, after the notice was distributed, a formal public hearing was requested by members of the public. Staff then prepared for the public hearing which was held by the Planning Commission on December 8, 2022.

The current proposal has already been elevated to a Planning Commission public hearing, in order to keep the level of review consistent. Therefore, it will not be postponed upon request.

If you or other community members would like to share input, you are welcome to submit written comments in advance or speak during the public hearing. All public comments will be included in the record and considered as part of the review process.

Dear Members of the Planning Commission,

I respectfully request that you **deny the proposal to establish a permanent 24-bed Addiction Services center in Skyhawk Village**. While I fully recognize the importance of addiction treatment and the valuable work these organizations do, this type of facility is **not appropriate for a residential neighborhood**.

Skyhawk Village is a small, community-oriented commercial area that serves the surrounding homes. The local businesses here are invested in maintaining a safe, welcoming environment that supports nearby residents and contributes positively to property values. These businesses rely on good relationships with the community and have a vested interest in keeping the area attractive and harmonious.

By contrast, a 24-bed detox facility does not depend on neighborhood support or participation. Its patients and visitors are not members of our community, and the operation of such a facility could introduce safety, parking, and compatibility challenges inconsistent with the character of Skyhawk Village. This location simply does not provide the infrastructure or setting suited for an intensive residential treatment program.

I urge the Commission to consider **alternative locations** in areas zoned for medical, institutional, or commercial services that can better support this important mission without negatively impacting a residential neighborhood.

To All Planning Commission Members,

My name is Kathleen Ramazzotti and I live on Owl Hill Avenue within the Skyhawk community. I am writing to relay my concern and OBJECTION regarding the now repeated request of Pura Vida Recovery Services, to yet again try and operate a "detox facility" for 24 participants. And, yet again, there are unmet concerns that need clarification and more details to consider accepting this proposal as a safe environment for our community members and all visitors. The notification of such a consideration was, yet again, deficient in appropriate notice to local impacted residents.

I am shocked that the Planning Commission would even reconsider this request based on the response and factual details that were presented three years ago and which facilitated a denial of the facility. The question is: why the Pura Vida Recovery Services owner/operator is trying to get this approved again, and spending \$12,000 just to get this passed through your department. The message from this surrounding community was VERY clear three years ago, with their concerns and the lack of details initially provided by the Pura Vida Recovery Services personnel, substantiated with several hundred petition signatures. Also, the Planning Commission voted against the Minor Use Permit after a public hearing on 12/8/2022 where many residents spoke against the passing of the request. That lack of information presented for this new request and the old reasons for denial, are still reasons to deny this request for the Pura Vida Recovery Services in 2025.

This proposed expansion on what is currently referred to as a "community care facility with 6 beds" certainly expands on its function.....asking to be allowed a DETOX facility for 24 clients - a quadrupled increase. It is now to be shadingly titled as a:

"Non-medical, monitored detoxification and withdrawal management for the addicted". Quite the contradiction between terminology and reality. As the details of staffing have not yet been clarified for the 24 clients (18 additional from today's residency), will it be 1 - or 2 - or? And, overnight shifts are always difficult to staff, so how many will be mandated to work at night? What needs to be the staffing number to be adequate for 24 "clients" with addiction withdrawal?

DETOX can be defined as: ***to abstain or rid the body of the addictive or unhealthy substances***. Detoxification should be medically monitored if we are

discussing medication addiction or illegal drug addiction. The next question is: how will they be 'medically monitored' in a "non-medical" facility? Will it be onsite or offsite ... by a physician? If offsite, what happens when a client/patient experiences a substance crisis and needs medication to quiet the crisis? How can that be controlled without a physician present to immediately administer needed medication at the moment of crisis? Or, is non-medical personnel allowed to administer prescription medication(s) that possibly should be **only** done by a licensed physician? And, how is this stretching of medical distribution law enforced or monitored? What happens when the out of control patient/client refuses the medication? Is the client then ejected immediately into the community on foot....and still suffering the addiction crisis? Does the now out-of-control-former-client become a hazard to him/her-self and others? The sad possibility in a mental crisis is the client may not recognize, nor care, about the traffic on Hwy 12 - just off property of their "non-medical facility" - and end up the victim of a traffic/pedestrian collision.

A Detox Program *Definition: a process or period of time in which one abstains from or rids the body of toxic or unhealthy substances.*

That may often include someone arriving in an actively using state with whatever substance

is the addiction, and is then "admitted" to a facility ... or sent away. It WILL have active users - without a doubt -- as that is why they call it a detox program. That encouraged presence in our community is the objection.

There is too much to lose with allowing the facility to expand in a location such as Skyhawk. Safety is tantamount of course - to young and old and anyone in between, property encroachment and/or trespass, theft, vandalism, possible physical harm/assault committed by someone actively using and becoming delusional or angry, along with other minor offenses that have been common in the neighborhood areas surrounding these facilities.

During the last attempt at this Detox Program location - a question was asked, and was conveniently left quiet until encouraged to answer ... that it was ALSO going to run an ACTIVE Walk-in Methadone Clinic. This then means they will be distributing drugs for addicts. Often the clients there for the medication are on the verge of a crisis before receiving the medication. Quite the contradiction for a "non-medical" facility.

The last issues of concern are, and still are, the lack of adequate personnel for the number of addicted clients that were to be allowed. Also no method of containment to prevent a client leaving if they choose, day or night. Now, with no transportation available, they wander through the residential areas or along Hwy 12. There also is that convenient bus stop immediately in front of the location for potential meet-ups with dealers and other users.....but also where students use the bus for school transportation and others without vehicles put to use. This is an additional major concern of youths being exposed to known addicts -- who often are still in possession of the addictive material, with Austin Creek Elementary School is very close by and many of the students walk to and from school and to the businesses in the same business complex. There is an overabundance of anger, trauma, drug availability and assaults in our society - let's not knowingly add more to our neighborhood streets.

How many customer complaints to the Skyhawk Villages businesses will happen for those customers to look elsewhere for businesses similar to Skyhawk Villages and refrain from utilizing our local business owners any longer. Worst of all, I believe it also violates the Santa Rosa City General Plan for this development and ***creates a liability for the city*** should you continue to support this proposal.

Please take your steps today to block this proposal...once and for all if possible. I would be happy to discuss any and all of these issues - again - should you like further conversation.

As a concerned resident of the Skyhawk community I would like to relay serious concerns I have about the proposed Pura Vida facility just minutes from my home.

I offer my concerns with the recognition of the need for facilities that offer help to those who suffer from addiction. Having a family member who has suffered from this for years I am very much aware of the impact it has on families and those around them that have to deal with it. I am very sympathetic to the suffering involved.

But I am concerned about what consequences a facility like this would have on Skyhawk and whether it is a good fit for us.

In my view there are three substantial reasons why a 24 bed detox/recovery center may not be suitable for Skyhawk:

1. Austin School is a short walk from the proposed location (less than 90 seconds by car).
2. At 24 beds the scale of the operation is not a good fit for the surrounding neighborhood.
3. And, is a recovery facility for drugs and alcohol which would be basically situated above a tavern a good idea?

Other concerns I have regarding the proposed facility:

Will this site be for detox and residential treatment?

Does Pura Vida plan to offer outpatient treatment?

Will patients with a history of violence be treated here?

Will there be 24 hour onsite security personnel?

If residents are allowed to have visitors what assurances do we have that they will be clean and sober?

How many times has police, fire, or other city services been called to any of the other Pura Vida sites in Santa Rosa?

There are other concerns as well but those cited are what resonate with me the most.

With so many empty commercial/industrial sites in Santa Rosa is it not feasible for Pura Vida to consider one of them as a better option than locating this facility in a family neighborhood?

Hello,

Thank you for your email and expressed interest in the proposed project.

This is a Minor Conditional Use Permit application, for which a public hearing is *not* required. The Zoning Code requires that Minor Conditional Use Permits are heard by the Zoning Administrator in a public meeting format. In 2022, a formal public hearing was requested, and Planning staff decided to elevate the matter to the Planning Commission due to the high amount of public interest. This time, staff decided to elevate the item to a Planning Commission public hearing in order to keep consistency with the processing of the previous application.

Zoning Code Section 20-50.050(A) states that a neighborhood meeting is required for a development proposal that is a discretionary project and *requires* a public hearing. Furthermore, Subsection E states that a notice of application is required for all applications which *require* a public hearing. Minor Conditional Use Permits do not require a public hearing, therefore a neighborhood meeting and a notice of application are not required.

The Planning Commission hearing on November 13th was duly noticed in compliance with all notification requirements set forth in the Zoning Code: a mailed notice to neighbors within 600 feet of the property, an onsite sign, and a notice in the Press Democrat 10 days prior to the meeting.

10 days notice of a hearing is what is required by the Zoning Code and what is typical for Minor Conditional Use Permits; therefore, staff is not recommending that the Planning Commission continue the item to a later meeting date. However, the Commission can do so if they choose.

The [meeting agenda](#) was posted last week, with all associated project documents as well as the staff report and draft resolution. I am happy to answer any further questions or provide any information, whether about the project itself or the Minor Conditional Use Permit process.

We are writing to you today on behalf of our concerned neighbors, particularly those residing in the Skyhawk Village area, to formally request the postponement of the Public Hearing scheduled for Thursday, November 13, 2025, regarding the proposed Pura Vida drug treatment facility.

Same request has been sent to each Commissioner.

The primary purpose of this request is to ensure the community has adequate time to learn about the newly submitted application and engage meaningfully in the public decision-making process before a final vote is cast.

Most neighbors were only made aware of this significant proposal when an informational sign was posted at the Skyhawk Village neighborhood shopping center on Halloween. This late notification is particularly concerning, especially considering the project's history: a similar application was filed by Pura Vida in 2022, met with strong neighborhood opposition, and was ultimately not approved by the Commission in December 2022.

The new application was filed on May 5, 2025. According to the Zoning Code, Section 20-50.050, a notice of application should have been mailed within 45 days of submittal, by June 19, 2025. If this notification had occurred, the community would have had ample time to review the details and have our questions addressed ahead of any scheduled public hearing.

Instead, when we saw the sign on Halloween and contacted city staff requesting a postponement to allow for proper community review, we received partial information and were told to file a Public Records Act (PRA) request to access project correspondence. Our PRA request was filed on November 5, 2025 and we understand it will take more than two weeks to receive the requested information. This timeline means we may not receive the full project file until long after the scheduled

hearing.

Given the City's commitment to equity and inclusion, as highlighted in the recently adopted General Plan 2050, we must respectfully point out that the current process has been neither inclusive nor respectful of our community's right to transparent engagement due to the following key factors:

1. Lack of Proactive Outreach: No pre-application neighborhood meeting was arranged in early 2025, an outreach effort that would have been appropriate given the strong and documented opposition to the prior proposal.
2. Disregard for Past Concerns: Proceeding with the hearing on November 13th, while the community awaits critical information via a PRA request, fundamentally prevents neighbors who demonstrated strong opposition in 2022 from being fully informed and engaged in this crucial second review.
3. Inadequate Notification Radius: The fact that a large contingent of community members who attended the 2022 hearing were unaware of this new application until late October suggests the current notification radius is insufficient to inform all affected neighbors.

We believe that postponing the hearing is the only path forward that aligns with the spirit of the City's proclaimed values of equity and respect for all communities. We are simply asking for the necessary and standard time to be engaged in a decision that directly impacts our neighborhood.

We urge the Planning Commission to postpone the November 13, 2025, public hearing to a date in early 2026 to ensure a fair and fully informed process.

Dear Chair Weeks and Members of the Planning Commission:

As a resident of Santa Rosa for over 35 years, I am writing to express my full support for the expansion of the Community Care Facility operated by Pura Vida Recovery Services at 5761 Mountain Hawk Drive.

For most of my life I was completely uninformed about the disease of alcohol and drug addiction, much less the operations of residential treatment centers. That all changed in October of 2023 when a member of my family recognized the need for in-patient treatment for alcohol and drug addiction. Because the availability of in-patient beds in Santa Rosa was virtually non-existent, my loved one entered a treatment center in Petaluma where a bed was immediately available. As any family member can attest, time is of the essence when an addicted loved one expresses a willingness to go into treatment. That quick decision was life-saving for my loved one and life-changing for our family. And while we are eternally grateful to the Petaluma treatment center for the incredible care and support my loved one received, it would have been far better for our family had he been able to receive in-patient treatment in Santa Rosa.

So what did I learn about treatment centers while my loved one was in treatment? I learned that treatment centers save lives, families, livelihoods and communities. I learned that addiction does not discriminate and nearly every family has been impacted by this disease in some way. I learned that treatment centers serve people from every walk of life - doctors, lawyers, teachers, corporate executives, employees from major North Bay employers, just to name a few. I learned that addiction is a family disease and having family members engaged in the treatment process is critical, which is hard to accomplish when family members have to travel to participate in the treatment process. I learned that treatment is not just detoxification - in fact, many patients do not need to medically detox - but it is first and foremost therapeutic and supportive care. I learned that treatment doesn't end when the addicted person leaves the facility - patients work with treatment center staff to build an after-care support system so they have a much better chance of long-term recovery once in-patient treatment ends.

And while I have no personal experience with Pura Vida Recovery's in-patient treatment center, I do have personal experience with its family support group. I became aware of this support group when I was in crisis during my loved one's addiction, and it became my lifeline throughout my loved one's treatment and early recovery. I am not aware of any other treatment center in our region that offers this level of support to families free of charge. It is just another example of Pura Vida' Recovery's excellence in the field of alcohol and substance abuse treatment.

I appreciate the fears expressed by the neighbors, but they are not based in reality. Pura Vida has an impeccable record at its existing site and has experienced none of the issues or concerns raised by neighbors. I can state unequivocally that if this facility were planned in or near my neighborhood, I would welcome it as a much-needed healthcare facility and asset to the community.

Dear Ms. Bisla, Planning Commission Members and Staff,

As a Santa Rosa resident, I am writing to express my strong support for Pura Vida Recovery Services' Minor Use Permit application to expand their residential treatment facility at 5761 Mountain Hawk Drive from 6 to 24 beds.

Personal Experience with Pura Vida

I have been part of the recovery community since 1988, and have been continuously sober for over 37 years, and I have witnessed firsthand the life-saving impact of quality residential treatment services. My youngest child completed Pura Vida's residential, PHP (Partial Hospitalization Program), and outpatient services and has now maintained sobriety for over five years. This achievement would not have been possible without access to comprehensive, evidence-based treatment like what Pura Vida provides.

My wife, a longtime, local criminal defense attorney, regularly sees the transformative outcomes of residential treatment in her practice. Many of her clients who have accessed these services have achieved permanent recovery and now lead successful, productive lives. The alternative—without adequate treatment resources—often results in continued cycling through the criminal justice system at tremendous cost to

individuals, families, and our community.

Critical Community Need

Our community desperately needs more in-depth treatment resources, not fewer. The economics of operating treatment facilities is extremely challenging, and we have witnessed several critical closures in recent years:

- **Azure Acres**, a 66-year-old treatment facility (founded in 1959), closed on October 9, 2025, despite its corporate owner Acadia Healthcare reporting record \$3.2 billion revenue. The 54-bed facility and several affiliated sites shut down, forcing clients to transfer to other facilities.
- **Orenda Center**, Sonoma County's detox facility for low-income residents, closed on July 1, 2023, when operations were transferred from DAAC to Buckelew Programs. Because Buckelew needed to obtain a new state license, the facility remained closed for approximately 12 months, forcing Sonoma County residents to travel 40 miles to Marin County for detox services before reopening in mid-2024.
- **R House**, a group home serving adolescents with dual-diagnosis (mental illness and substance use disorders), closed in March 2020 after 45 years of operation due to \$250,000 in losses from costly upgrades required by new state regulations.

These closures demonstrate how fragile our treatment infrastructure is. When businesses are willing to invest in providing these critical life-saving services in our community, we have an obligation to facilitate their operations, not create unnecessary barriers.

Pura Vida's Proven Track Record

According to the application materials, Pura Vida has operated a 6-bed facility at this exact location for nearly three years without any complaints to the City, neighboring businesses, or landlords. The application documents state there have been **zero law enforcement calls for service** related to their residents. This exemplary record speaks to their professional operations and commitment to being good neighbors.

Key facts supporting this application:

1. **No Service Changes:** The 24-bed facility will provide the exact same services already operating successfully for three years
2. **24/7 Supervision:** Residents are supervised by 4-6 staff members around the clock, including nighttime bed-checks

3. **Structured Environment:** Residents are not permitted to go anywhere unattended and follow a structured treatment schedule
4. **No Traffic Impact:** A professional Trip Generation Memo found their use will have no increase on traffic, and may actually reduce traffic compared to general residential use
5. **No Displacement:** All existing businesses remain and have not been negatively impacted; nearly all neighboring businesses have submitted letters of support
6. **Limited to Residential Treatment:** No outpatient services or medication-assisted treatment (Methadone) will be provided at the site

Regulatory Oversight and Standards

Pura Vida maintains:

- An active and unblemished license from the California Department of Healthcare Services
- An active and unblemished accreditation from the Joint Commission

These regulatory bodies have strict guidelines for client safety and facility operation, ensuring the highest standards of care and community safety.

Consistency with General Plan

This application actively advances Santa Rosa General Plan Policy 6-2.3: "Prevent, disincentivize, and reduce harmful addictive behaviors." Pura Vida is a Community Care Facility as defined in Santa Rosa's zoning code and California Health and Safety Code. Notably, the City has already issued two separate Minor Use Permits to Pura Vida for other locations of the same nature and use, establishing precedent for this approval.

Conclusion

The "Not In My Back Yard" reaction to this application is understandable but misplaced. Pura Vida has demonstrated nearly three years of exemplary operations at this exact location with zero complaints or incidents. They are not proposing new services—only expanding capacity for services that already exist and operate successfully at this site.

Our community cannot afford to lose another treatment resource. Every day we delay expanding access to treatment, people in our community struggle with addiction, families suffer, and the cycle continues. When we have a licensed, accredited, professionally-operated treatment provider willing to invest in our community, we must

support them.

I will be attending the Planning Commission meeting on Thursday, November 13, 2025, at 4:30 PM at City Hall to speak in support of this application. I urge the Planning Commission to approve Pura Vida's Minor Use Permit application.

Our beloved Skyhawk community is in danger of disruption due to the proposed establishment of a 24-bed detox center. This facility, operated by Pura Vida Recovery Services, is planned to be located alarmingly close to Austin Creek Elementary School. The safety and tranquility of our neighborhood are at stake, and the decision now rests in the hands of the City of Santa Rosa, pending a Minor Use Permit application.

The proximity of this detox center to an elementary school raises severe concerns about the safety of our children and the impact on our community. Parents and residents worry about the increased traffic congestion, especially near the Hwy 12 entrance, which is already heavily used. The addition of this facility would exacerbate existing traffic problems, making commuting more difficult for families and residents.

Detox is a process or period of time in which one abstains from or rids the body of toxic or unhealthy substances. So that may often include someone coming in actively using whatever drug at the moment, and is then "admitted" to a facility or sent away. It will have active users, without a doubt, as that is why they call it a DETOX center. That encouraged presence in our community is the objection. There will be too much to lose for our community: safety, property encroachment, theft, possible physical harm by someone actively using and angry if turned away for not complying with rules, along with other minor offenses that have been common in the areas of these facilities.

There is also a concern for its lack of adequate personnel for the number of addicted clients that were to be allowed, and no method of containment if a client chooses to leave, day or night. There is a bus stop immediately in front of the location for meet-ups with dealers, where students use the bus for school transportation. This is a major concern of youths being exposed to known addicts who often are in possession of the addictive material.

Let's not forget that this is not the first time we have faced this issue. Three years ago, more than 400 vigilant and concerned members of our community successfully banded together to prevent Pura Vida Recovery Services from securing the permit for a similar project. Our collective voice was heard then, and it must be heard again.

The City of Santa Rosa has scheduled a public hearing on November 13, 2025, at City Hall starting at 4:30 PM. It is crucial that we act now to voice our concerns and show our unified opposition before this hearing takes place. Our gathered presence and signatures can once again influence this decision.

We call upon the City of Santa Rosa to reconsider the decision to grant this Minor Use Permit and to protect the family's community and the wellbeing of our children. This proposed detox facility could be relocated to a more appropriate area where it would not disrupt the lives of residents in a peaceful neighborhood.

PROJECT NAME - Pura Vida Recovery Services

Hello, my name is David Schwartz. I am a resident homeowner in the St. Francis subdivision adjacent to the Skyhawk neighborhood in Santa Rosa.

I am here to present my views and opinion regarding the Pure Vida Recovery Services proposal to expand the number of beds from 6 to 24 in the Skyhawk Village. This proposal is to provide non-medical, monitored detoxification and withdrawal management for the addicted.

As a concerned citizen, I understand and recognize the need for this form of treatment. Many of our fellow humans and citizens are in need of a wide range of help, guidance and support.

I don't want to come across as sanctimonious, but I do not support this proposal in the Skyhawk neighborhood.

The Skyhawk and St. Francis neighborhoods are a middle to upper class residential area of Santa Rosa. This is not a community with commercial, medical or office activities, it's a residential community of hard working people, many raising families, seniors, kids riding bikes, people out for a walk. Just about anytime of day, you can find people walking their dogs, playing with their kids, hiking and biking. It's a pleasant place to live.

The City of Santa Rosa is misguided for allowing services such as Pure Vida in this neighborhood.

Just yards in front of the Skyhawk Village plaza where the Pure Vida expansion is proposed, the City of Santa Rosa has allowed vehicles of all types to be stacked up with for sale signs along Highway 12, creating a visual and parking stain on the neighborhood. Simple NO PARKING signs could easily and quickly rectify this problem.

The level and amount of panhandling along Highway 12 is also alarming and concerning. The City appears to allow this behavior to go on without penalty. The level of median strip panhandling cheapens the Santa Rosa brand as the center of Sonoma's Wine Country and risks people's lives along the busy Highway 12 corridor.

Santa Rosa would benefit from learning how San Francisco has demonstrated zero tolerance for street panhandling. Highway 12 is a fast boulevard. Someone is going to get injured or killed if this is not addressed.

The level of homelessness at Highway 12 along Santa Rosa Creek is out of control.

Skyhawk Village is probably the worst possible location to place a facility such as Pure Vida.

Within a **few feet** of the proposed Pure Vida expansion, is a restaurant with a full alcohol bar.

Within a half mile are two well displayed Marijuana dispensaries and additional restaurants serving full bar alcohol.

Within a few blocks of the proposed bed expansion is an elementary school, a children's playground, nature trails, creeks and culverts with a lot of places where unhoused people can hide and loiter.

Skyhawk Village is literally the final residential neighborhood before traveling south into the wide open rural countryside along Highway 12.

Skyhawk Village seems to me to be the worst possible place to expand a recovery service for people detoxing and withdrawing with terrible addictions.

The nearest hospital is 4.8 miles away.

Pure Vida's web site shows they are located on Cleveland Avenue in Santa Rosa.

There is **NO** mention of the current 6 bed facility at Skyhawk Village. The lack of Pure Vida's transparency of the current 6 bed facility at Skyhawk Village is concerning. ***What is Pure Vida hiding?*** This Pure Vida proposal suggests the bed expansion by a whopping 400%!!

While I'm not familiar with the Cleveland Avenue facility, with proximity to nearby City and County services, hospitals and commercial services, this seems to be a more appropriate location to house a facility for people needing physical, psychological and emotional support when detoxing from addictions. **Not** adjacent to a neighborhood filled with children and families where this expansion is proposed.

The adjoining St. Francis and Skyhawk neighborhoods are filled with hundreds of homes and taxpayers that pay the City of Santa Rosa a significant amount of property taxes, sales taxes, county, state and federal taxes.

This is not a neighborhood appropriate for a commercial business such as Pure Vida to make money while helping people in desperate need. It seems there are more appropriate areas of Santa Rosa to place and perform these needed services. I am strongly against Pure Vida's proposal and indeed, their existing "ghost" facility in Skyhawk Village.

Please city representatives, would you do something to address the chronic panhandling and chronic parking situation along Highway 12.

I am writing to express my wholehearted support for the use permit application for Pura Vida Recovery, an alcohol and drug rehabilitation program proposed in Santa Rosa. As the former Chief of Licensing for the California Department of Health Care Services (DHCS), I have spent much of my career working with substance use disorder treatment programs throughout California.

My experience includes extensive familiarity with the Health and Safety Code and Title 9 regulations that govern these facilities. I understand not only what the law requires but also how responsible, well-managed programs can make a meaningful difference in the lives of individuals and the communities they serve. I have been a licensing and compliance consultant, and expert witness in wrongful death cases, for the last 11 years.

Most importantly, Pura Vida Recovery is a non-medical residential program, as defined in the California Health and Safety Code §11834.02 and Title 9, Division 4, Chapter 5, Section 10501(a)(6) of the California Code of Regulations. The H&S code, which is law, states as follows: 11834.02(a) *“As used in this chapter, ‘alcohol or other drug recovery or treatment facility’ or ‘facility’ means a premises, place, or building that provides residential nonmedical services to adults who are recovering from problems related to alcohol, drug, or alcohol and drug misuse or addiction, and who need alcohol, drug, or alcohol and drug recovery treatment or detoxification services.”*

This means the facility does not provide medical treatment services but instead offers structured, supportive recovery in a home-like environment where individuals can safely begin the process of rebuilding their



lives. Programs of this kind are designed to foster personal growth, accountability, and community reintegration—key components of long-term recovery. The law does not allow this type of facility to be classified as medical; however, some incidental medical services are provided, such as prescribing medications.

Throughout my career, I have witnessed the positive impact that ethical, well-regulated recovery programs can have on both clients and neighborhoods. Pura Vida Recovery's leadership has demonstrated a commitment to compliance, integrity, and community partnership. Their program will provide a vital local resource for individuals and families affected by addiction—helping residents of Santa Rosa heal and return to productive, fulfilling lives.

I believe this project represents not only compliance with state and local requirements but also compassion in action. By approving this use permit, the Planning Commission has an opportunity to support a program that aligns with the highest standards of care while directly addressing a pressing community need.

Santa Rosa, like many California communities, continues to face the far-reaching impacts of substance use disorders. Programs such as Pura Vida Recovery play a vital role in supporting individuals and families affected by addiction. Speaking Points for 11/13/25 Planning Meeting

Thank you for allowing me time to speak. My name is DJ Phimister and I live on Owl Hill Avenue.

This project was denied three years ago for a variety of reasons. Nothing since then has substantially changed. Slight correction on that, City staff approved Zoning Clearances that allowed conversion of the apartments to facilitate this project. This was done without notification or community input, or mention of the neighborhood's previous opposition. Two years ago, I suggested there be some kind of meeting between all involved to sort through the numerous issues which cannot possibly be addressed in the few minutes I have to speak. Again, I would request this hearing be postponed and a City facilitated meeting be arranged so we can go through the issues properly.

Briefly some top items are:

I think everyone here would agree rehab facilities are a good thing. But this is the wrong place.

We are eliminating existing rental housing and defying the purpose of the "complete neighborhood" shopping center concept by doing so.

It does not fit with the concept of a "community center." The applicant infers, and City Staff repeat, that a good portion of their clientele come from the neighborhood. We have no proof of that. How many clients have they had since they opened? How many were from the neighborhood? How do they define the parameters of the neighborhood?

The applicant does not have experience in managing a facility this large, his other facilities are much smaller.

The applicant states they are not a medical facility. However, they will have a doctor and nurses on staff and the staff will be administering medication and determining if individual clients are having problems, in need of additional medication or medical attention. It sounds very much like a medical facility.

Applicant states there will be no sex offenders or violent felons allowed as clients. How will that be enforced? How will we know if it is being adhered to? Do the same conditions apply to the staff?

Will any of the “self-administered” medications involve the use of syringes?

The smoking area originally proposed has been eliminated, which means we can/will have concentrated groups of people smoking in the parking lot or adjacent park increasing the probability of secondhand smoke issues.

The applicant originally proposed a walk-in clinic where people, not clients of the live-in facility, could pick up their drugs. These are typically locations where offenders show up to buy and sell illegal drugs. Will such a facility be part of a future request? If the applicant states that he no longer intends to pursue this, is there really any way to prevent it?

In the building renovation drawing, I see nothing regarding video surveillance on the property. At the very least, I believe it should be required on the balcony at the facility entrances, and on the main walkways to the building.

Is Pura Vida required to maintain a minimum amount of liability insurance? Can they be required to?

Is any of this ADA accessible? Doors, countertops, bathrooms, etc.? The drawings are not adequate to determine compliance.

There is absolutely nothing preventing a client who decides to quit the program from walking out in the middle of the night. What policies or procedures do the staff have for dealing with such an occurrence? Said client could be from another County and will now be walking around the neighborhood unsupervised with no means of transportation. With 24 clients dealing with addiction this is bound to happen. How will Pura Vida protect the neighborhood?

The only way this project meets the necessary criteria is if there are zoning clearance changes (something that apparently has already been completed without the knowledge or input of the neighborhood) and we take everything the applicant has stated at face value. The City has had this information for several months but we have only had 10 days to prepare for this meeting. We don't really know the full facts of everything going on here. The City is dedicated to transparency and I believe the client wants to create a relationship of trust with the community. This has not been accomplished, and possibly the exact opposite has occurred. Making decisions on partial facts, when there is no reason to rush this, is not good business practice. I would request the proposal be put on hold until a City sponsored meeting can be scheduled. We can then wade through the concerns and input from all so the City can make a proper determination on the applicant's request.

Dear Chair Weeks and Planning Commissioners:

We, neighbors of the Skyhawk Village shopping center, are writing again to respectfully request that the public hearing scheduled for November 13, 2025 be postponed and to provide additional information supporting this request. If the hearing proceeds, we urge you to deny the Minor Conditional Use Permit for the Pura Vida Large Community Care Facility.

Grounds for Postponement

We previously requested a postponement on November 10, 2025, to provide more time for affected neighbors to learn about the proposal, and we received an immediate staff response. Staff explained that they had decided to elevate this item to the Planning Commission with an associated public hearing to be consistent with how the previous 2022 application was handled. They further explained that a Notice of Application and Neighborhood Meeting are not necessary for land use matters when a public hearing is not required by the Zoning Code. This appears to be an inconsistent approach and underscores our concerns that the City's notification process of the proposed 2025 Pura Vida project has been highly problematic, as further explained below:

Excessive Delay: The subject application was filed on May 5, 2025. City staff waited 177 days, until just before Thanksgiving 2025, to schedule the public hearing and issue formal public notices 10 days ahead of the scheduled meeting. This is despite their decision six months ago that the project would involve a public hearing at Planning Commission. The decision not to conduct early outreach resulted in members of the Skyhawk community becoming aware of the new project only 10 days ahead of the scheduled public hearing.

Lack of Community Engagement: The City's failure to schedule a Notice of Application and a City-sponsored Neighborhood Meeting in summer 2025 has negatively affected our community. Early notification of the proposed project would have allowed for critical transparency and community dialogue months ago. While we understand that these outreach methods aren't required for Minor Conditional Use Permits, we believe that City staff should have decided to conduct early outreach given their awareness of our community's concerns about the 2022 proposal.

These procedural missteps undermine public trust and are at odds with the principles of government transparency, limiting the Skyhawk community's ability to participate effectively in this decision-making process.

Public Records Act Request and Subsequent New Information

We filed a Public Records Act (PRA) request on November 5, 2025, seeking all correspondence and meeting records between the City and Pura Vida regarding the facility at 5761 Mountain Hawk Drive between January 1, 2025, and the present. We are still waiting for the initial 14-day PRA review period to pass, and understand that requested documents may not be received until December or January.

On November 7, 2025, the staff report for the November 13, 2025, meeting was published. This report contains new, previously unshared information that warrants further investigation and discussion.

Concerns Regarding Prior Application Handling

The staff report includes unexplained information regarding the prior 2022 application. After the December 8, 2022 Planning Commission meeting, City staff was directed to return to the Commission with a resolution of denial. However, the resolution never returned to the Commission agenda (it did not appear on the December 14th agenda, the December 22, 2022 meeting was canceled, and it was absent from the January 2023 agendas). The staff report states the Minor Conditional Use Permit was withdrawn on January 26, 2023. Beyond this statement, there is no explanation as to why City staff did not schedule the resolution for final action. This omission of information raises serious concerns about transparency and trust.

New Facts Requiring Review

The November 13, 2025, staff report also introduces two additional "facts" regarding "Zoning Clearances" issued on April 12, 2023, and February 27, 2025. There is no explanation of why the clearances were applied for, how they were evaluated, or why they were issued. The community needs the opportunity to submit an additional PRA request to receive the applications, correspondence, and meeting records that might clarify these Zoning Clearances. Without a continuance of the public hearing, there is no time for the required PRA request to be filed, documents to be received, or information to be reviewed.

Failure to Address Previous Concerns

Lastly, the staff report identifies that the previous application received opposition from both the community and the Planning Commission. However, there is no analysis of how the current revised project addresses the concerns of either group. We need assurance that the Commission is aware of the community's previous concerns, and we request that the entire December 8, 2022 agenda packet, including all public correspondence, be reviewed by the current Commission and included in the record associated with the 2025 application.

I have achieved sobriety, own a successful business and employ almost 100 people with my husband -40 years in AA and my brother

Also sober 30 years. So we know a lot about people and recovery.

3 of our children are in recovery.

My son Ryan, was hiding his using and eventually couldn't any longer. He was smoking drugs... when he hit bottom he had no where to go.

We couldn't afford 35,000 for a 30 day program and he did not have insurance (he was 34 years old)

I called Ben, a few days later in moved into residential sober living where he stayed about 1 year and ½. That was almost 3 years ago. He has been Sober, working and happy since.

I visited him at least once a week at his house in Wikiup. Well over 50 visits and never did I see anyone walking around loaded or acting out. The house

And yard was spotless always. My son was safe and learned how to live. He learned how to live with 3 roommates, how to do house chores, go to meetings,

Respect his housemates, get along with people and stay clean and sober.

This program is run by professional people a lot who are in the program themselves so they actually know what they are doing.

My son wasn't dangerous, he was desperate and hopeless – he needed help that was long term and affordable and effective.

With 40 years of experience, I have seen it all. Without a single doubt I highly recommend that you let this program open. The alternative of not allowing Pura Vida

Beds for young adults, mothers, dads, professional people etc is really sad, based on fear and short sighted. This is a company with a proven track record, they know

What they are doing and they are actually helping to strengthen our community and save lives.

Dear Planning Commission,

Three years ago, over 400 people from the Skyhawk community signed a petition seeking to BLOCK the proposal to establish a permanent 24-bed Addiction Services center in Skyhawk Village under the guise of a community services center. The Planning Commission voted against the Minor Use Permit after a public hearing on 12/8/2022 where many residents spoke against it.

Now Pura Vida is re-submitting the application to try a second time to get a Minor User Permit to operate a 24-bed recovery center. Such a recovery center is too close to Austin Creek Elementary. It blocks traffic and takes customers away from other small businesses. Worst of all, it also violates the Santa Rosa city General Plan and creates a liability for the city should you continue to support this proposal.

Furthermore, I am shocked by the short notice for the reapplication. I am a taxpayer and voter-providing such shockingly short notice for such a volatile and divisive issue is simply wrong. I do not deserve to be marginalized in such a manner.

My children have frequented the area behind the building for the last few years. It is one of the best spots for my kids to catch tadpoles. We love to metal detect in the area to find clues to the long abandoned homestead that once stood there. I and other parents do not leave our children there alone. This is because of the folks frequently smoking and gathering at the picnic table behind the building. Recently I had one attempt to engage in a conversation with my 10 year old. When I firmly told him to "back off" he said he is allowed as "I am staying up there" pointing to the apartments. Prior to this I assumed it was just the local homeless/residents. I now know (after the skhawk community meeting 11/12) it is the folks already enrolled in the rehab. I am shocked that after this proposal was rejected that this facility was allowed to expand. I have rights. I do not deserve to be marginalized. We deserve time to discuss and the city must respond and explain what has changed since the last rejection.

Please take steps today to block this proposal.

Dear Chair Weeks and Members of the Planning Commission:

As a resident of Santa Rosa for over 35 years, I am writing to express my full support for the expansion of the Community Care Facility operated by Pura Vida Recovery Services at 5761 Mountain Hawk Drive.

For most of my life I was completely uninformed about the disease of alcohol and drug addiction, much less the operations of residential treatment centers. That all changed in October of 2023 when a member of my family recognized the need for in-patient treatment for alcohol and drug addiction. Because the availability of in-patient beds in Santa Rosa was virtually non-existent, my loved one entered a treatment center in Petaluma where a bed was immediately available. As any family member can attest, time is of the essence when an addicted loved one expresses a willingness to go into treatment. That quick decision was life-saving for my loved one and life-changing for our family. And while we are eternally grateful to the Petaluma treatment center for the incredible care and support my loved one received, it would have been far better for our family had he been able to receive in-patient treatment in Santa Rosa.


So what did I learn about treatment centers while my loved one was in treatment? I learned that treatment centers save lives, families, livelihoods and communities. I learned that addiction does not discriminate and nearly every family has been impacted by this disease in some way. I learned that treatment centers serve people from every walk of life - doctors, lawyers, teachers, corporate executives, employees from major North Bay employers, just to name a few. I learned that addiction is a family disease and having family members engaged in the treatment process is critical, which is hard to accomplish when family members have to travel to participate in the treatment process. I learned that treatment is not just detoxification - in fact, many patients do not need to medically detox - but it is first and foremost therapeutic and supportive care. I learned that treatment doesn't end when the addicted person leaves the facility - patients work with treatment center staff to build an after-care support system so they have a much better chance of long-term recovery once in-patient treatment ends.

And while I have no personal experience with Pura Vida Recovery's in-patient treatment center, I do have personal experience with its family support group. I became aware of this support group when I was in crisis during my loved one's addiction, and it became my lifeline throughout my loved one's treatment and early recovery. I am not aware of any other treatment center in our region that offers this level of support to families free of charge. It is just another example of Pura Vida' Recovery's excellence in the field of alcohol and substance abuse treatment.

I appreciate the fears expressed by the neighbors, but they are not based in reality. Pura Vida has an impeccable record at its existing site and has experienced none of the issues or concerns raised by neighbors. I can state unequivocally that if this facility were planned in or near my neighborhood, I would welcome it as a much-needed healthcare facility and asset to the community.
