anta Rosa HOST Background

- City-sponsored program August 2015
- Street outreach team
- Clean Start & HEAP
- Housing First Fund March 2018
- 2018-2019 Accomplishments
 - 334 served
 - 171 sheltered
 - 137 housed
 - 77% housing retention rate



ta Rosa HOST 2018-2019

- Council approves \$1,000,450
 - Grant Agreement for HOST Program
 - First Amendment Housing First Fund

Tenant Assistance	\$28,000
Housing Assistance	\$200,000
Operational Expenses	<u>\$106,000</u>

- Council approves \$1,000,450
 - Second Amendment \$557,350
- Catholic Charities deploying housing funds
- Third Amendment
 - \$443,100 commit balance

Operational Expenses	<u>\$43,100</u>
Previously Budgeted	\$443,100
HCV Support – General Fund	<u>\$35,000</u>

nta Rosa Housing Choice Voucher program

 Housing Anti-Discrimination Code passed October 1, 2019; adoption in 30 days

 Council requested owner incentives parallel
 Ordinance adoption including immediate access to existing risk mitigation pool



inta Rosa Housing Choice Voucher program

- \$35,000 expands access to existing risk mitigation funds to cover HCV participants
- Housing Authority will continue to explore longterm HCV loss mitigation strategy and owner incentives
- Future General Fund may be requested to support;
 HUD funding is limited to program administration and rental assistance only



Rosa RECOMMENDATION (1 of 2)

It is recommended by the Housing and Community Services Department that the Council, by resolution, 1) approve a Third Amendment to Grant Agreement for Homeless Outreach Services Team (HOST) Program with Catholic Charities of the Diocese of Santa Rosa, in the amount of \$478,100, for the continued administration of a Housing First Fund (landlord incentives, risk mitigation, tenant assistance, housing assistance) to include access to risk mitigation funding for the Santa Rosa Housing Authority's Section 8 Housing Choice Voucher (HCV) Program, (continued)



a Rosa RECOMMENDATION (2 of 2)

bringing the total amount of the agreement to \$1,035,450 for Fiscal Year 2019-2020; and 2) authorize the Chief Financial Officer to appropriate \$35,000 from the General Fund unassigned reserves to the Homeless Shelter Operations Fund for HOST's administration of risk mitigation funding for the HCV Program.
