RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING AMENDMENT NO. 2 TO MINNESOTA NATIONAL ASSOCIATION OF STATE PROCUREMENT OFFICIALS (NASPO) MASTER AGREEMENT 23026 FOR THE CONTINUED PURCHASE OF COMPUTER AND SERVER EQUIPMENT FROM DELL MARKETING, L.P. AND AUTHORIZING THE CONTINUED USE OF AGREEMENT NO. 23026 THROUGH JUNE 30, 2028 IN AN AMOUNT NOT TO EXCEED \$2,100,000

WHEREAS, the Information Technology Department purchases and supports approximately 2,000 PCs, laptops, and tablets for city staff use, as well as servers, and has designed a selection, purchasing and deployment process optimized for efficiency and cost management; and

WHEREAS, the City standardized on Dell equipment in 2007, and has most recently been procuring Dell equipment through the National Association of State Procurement Officials (NASPO) Minnesota Master Agreement No. 23004; and

WHEREAS, the Information Technology Department last went to Council on August 8, 2023, for approval to continue purchasing equipment through June 30, 2025; and

WHEREAS, the Minnesota National Association of State Procurement Officials (NASPO) Master Agreement 23004 was set to expire on that same date; and

WHEREAS, effective July 1, 2025, the NASPO Master Agreement 23004 has been extended through June 30, 2026, with additional extension options through June 30, 2028; and

WHEREAS, the Information Technology Department recommends Council approve the continued use of Agreement No. 23004 for procurement of Dell products; and

WHEREAS, the NASPO cooperative agreement for Computer Equipment, Peripherals & Related Services and California Participating Addendum require purchase orders (POs) be provided as part of its ordering process.

NOW, THEREFORE, BE IT RESOLVED that the Council approves Amendment No. 2 to NASPO Master Agreement 23026, in substantially the same form as Exhibit A to the resolution, subject to approval as to form by the City Attorney, for continued purchase of Dell computers, monitors and server equipment from Dell Marketing L.P., in an amount not to exceed \$2,100,000 for 3 years beginning July 1, 2025 through June 30, 2028.
