Purpose

The Public Art Program is intended to enrich civic life, give voice to the unique spirit of Santa Rosa, and galvanize the City's reputation as an arts destination. The Program integrates a wide range of art into public spaces, creating a livable community and contributing to economic development.



Project Development Process

- Annual Work Plan
 - Outlines which Creative Zone the Program will focus on
- Public Art Project Plan
 - Developed for each public art project
 - Guides planning and execution



Project Approval Process

- Provides clarity for the following:
 - Artist Solicitation
 - Artist Selection
 - Selection Criteria
- Additional Guidelines may be developed by APPC/staff as needed



Project Approval Process

- Curators
 - Alternative to issuing a call directly to artists
- Selection Panel
 - APPC may serve or opt to form separate panel
 - Select one or more artists and forward recommendation to APPC for approval
- Artist Agreement
 - Includes scope of work, fee, schedule and relevant terms and conditions
 - Director of Recreation & Parks approval

Gifts and Loans

- Technical Review
 - Arts Coordinator
- Aesthetic Review
 - APPC using established criteria
- Director of Recreation & Parks approval



Relocation or Deaccession

- Criteria
 - Site, security, safety, maintenance
- Review
 - APPC using established criteria; forward recommendation to City Council for approval



Art in Public Places Committee

Possess professional experience in the field of visual or public art, including, but not limited to, artists, arts administrators, curators or producers of public art, scholars or teachers;

OR

Possess experience and knowledge of environmental design, placemaking, economic development, tourism, or a background or general interest in other aspects of the arts.
