7. REPORT ITEMS

7.1 REPORT - ACCEPTANCE OF FINAL TOTAL PHOSPHORUS
BLUE-RIBBON PANEL REPORT

BACKGROUND: The Phosphorus Blue-Ribbon Panel (BRP) identified a set of principles that supports watershed-oriented, cost-effective mitigation measures in response to the City's existing nutrient water quality limits related to Total Phosphorus (TP) discharges from the Laguna Treatment Plant. The goal was to explore an alternative approach to provide the City a consistent compliance mechanism while providing reliable, ongoing benefits to the ecosystem within the Laguna de Santa Rosa watershed that could replace the City's existing risk-based, calculated offset requirement for TP discharges which has proven uncertain, unreliable and has only provided intermittent benefits

to the watershed.

In addition to identifying principles for phosphorus offsets, the BRP Final Report documents alternative compliance mechanisms including the North Coast Regional Water Quality Control Board's Water Quality Trading Framework and the joint effort of the Laguna de Santa Rosa Foundation, Russian Riverkeeper and the City of Santa Rosa's Alternative Compliance Program.

RECOMMENDATION: It is recommended by the Water Department that the Board of Public Utilities, by motion, accept the findings in the final Total Phosphorus Blue-Ribbon Panel Report.
