AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 2. Compensation

Section 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$490,000 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of one million and nine thousand dollars (\$1,009,000) The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number 050802."

2. Section 11. Term, Suspension, Termination.

Section 11(a) is amended to read as follows:

- a. This Amendment shall become effective on July 1, 2018, set forth on the first page of the Agreement, and shall continue through June 30, 2029.
- 3. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than June 30, 2029.

All other terms of the Agreement shall remain in full force and effect.
