BACKGROUND: Concept Landmark Alteration Permit to obtain guidance from the Cultural Heritage Board on the following proposed changes: 1) Add brick steps from brick walkway to the porch, 2) Replace rotten wood steps from driveway to porch with bricks, 3) Add brick skirt to front of house to cover foundation at porch height, 4) Replace existing brick/concrete driveway with brick, 5) Install brick walkways in front, 6) Install small fountain on brick walkway to front door, 7) Replace existing rotten porch deck with brick, 8) Landscape/hardscape brick
