RECITALS

- A. City and Consultant entered into the Agreement for Consultant to provide plan review services to supplement the City of Santa Rosa's existing staff.
- B. City and Consultant now desire to amend the Agreement for the purpose of increasing total compensation and extending the time of performance.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 2. Compensation

Section 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$100,000.00 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of three hundred ninety five-thousand dollars and no cents (\$395,000.00). The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number 080202-5320."

2. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than March 31, 2017."

All other terms of the Agreement shall remain in full force and effect.
