

**FIFTH AMENDMENT
TO GENERAL SERVICES AGREEMENT NUMBER F001776
WITH PETRUSHA ENTERPRISES, INC.
DBA ADVANCED SECURITY SYSTEMS**

This Fifth Amendment to Agreement number F001776, dated October 1, 2018, ("Agreement") is made as of this _____ day of _____, 2021, by and between the City of Santa Rosa, a municipal corporation ("City"), and Petrusha Enterprises, Inc., dba Advanced Security Systems, a California Corporation ("Contractor").

RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide fire and burglar alarm monitoring services, as previously amended.
- B. City and Contractor now desire to amend the Agreement for the purposes of extending the term for two years with no increase in unit cost, and increasing compensation.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional two years.

2. COMPENSATION

Section 4 of the Agreement is amended to increase the funds payable to Contractor under the Agreement by \$70,000 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$150,788. The Chief Financial Officer is authorized to pay all proper claims from various Charge Numbers."
