In the second of two orders released on September 30, 2025, the Federal Communications Commission (FCC) adopted a Notice of Proposed Rulemaking (NPRM) proposing reforms that purportedly would "free towers and other wireless infrastructure from regulatory burdens imposed at the state and local level." An analysis of the other FCC order focused on wireline deployments can be found here. This second FCC order proposes rule changes that have been on the wireless industry wish list for some time and industry comments will be voluminous. It is crucial for local governments to voice their concerns about the proposed rule changes.

Please comment on the FCC's docket to say that you want to keep your local telecom ordinance in place. Their proposal would strip cities and counties of local control. Your ordinances would mean nothing. Game over.
