15.2 REPORT - MEASURE O CYCLE IX CHOICE GRANT PROGRAM FUNDING RECOMMENDATIONS

BACKGROUND: The Measure O Transaction and Use tax passed by voters in 2004 allocates grant funding to organizations for youth and parenting programs which focus on gang and anti-violence education, prevention and intervention, community safety, and a comprehensive array of social services in high need neighborhoods. On September 29, 2017, the City of Santa Rosa released a Request for Qualifications for the Measure O Cycle IX CHOICE Grant Program with \$736,700 in available funding per year of the two-year cycle from January 1, 2018-December 31, 2019. Staff will present the funding recommendations from the Grant Review Team.
