RE: Assembly Bill 698 - Energy: gas stoves - Notice of Opposition (As Amended on March 9, 2023)

NATALIE ROGERS On behalf of the City of Santa Rosa, I write to express our respectful opposition to your Assembly Bill (AB) 698, which would prohibit state agencies and local governments from DIANNA MACDONALD adopting or enforcing a rule, regulation, resolution, or ordinance that directly or indirectly Vice Mayor results in prohibiting the use of gas stoves in residential and nonresidential buildings.

VICTORIA FLEMING This bill would remove much needed local control in the fight against climate change. Gas JEFF OKREPKIE stoves not only contribute to climate change through their use of natural gas; they also emit harmful chemicals into the air which are confined in the home and therefore lead to asthma and other respiratory illnesses. This bill would remove the ability for the City to help fight climate change, as well as help protect the health of its residents. Not allowing local governments to ban gas stoves therefore poses a public health risk to residents across California and also removes the ability of local governments to help reduce greenhouse gas emissions and thus reduce the impact of global climate change.

> A recent study in the International Journal of Environmental Research and Public Health showed that natural gas is more toxic than previously thought, and that gas stoves also leak harmful pollutants1. The study estimated that 20% childhood asthma cases in California are due to the use of gas stoves. In 2022, the American Public Health Associated noted that gas stoves are the source of air pollutants that present dangerous health impacts to children and other at-risk groups<sup>2</sup>. Another recent study showed that natural gas stove use is linked

to alarming rates of childhood asthma. Richard Trumka, Jr., the commissioner of the federal Consumer Product Safety Commission, has called gas stoves a hidden hazard and that any option to replace them must be on the table. Future regulations are thus needed to curb this public health risk, and this bill would prohibit any future regulations at the local level.

On November 19, 2019, the City of Santa Rosa passed an ordinance titled "All-Electric Low Rise Residential Reach Code" that would require all new residential construction of 3-stories and below in the City to be all electric. Santa Rosa was one of the first cities in the country to pass an all-electric reach ordinance. As you may know, in addition to reducing fossil fuels, all-electric buildings can be safer and healthier to work and are cost effective, especially when designed at the new construction stage.
