

Council Follow-up from May 19, 2015 Budget Study Session

1. Provide projected fund balances for Police Department managed funds (Provided 5/22/15)

Staff Response: This question of fund balances came up several times during the presentation. When we provide the materials for the June budget hearings, all this information will be included. We have over 100 separate funds that are managed by departmental staff and the Finance Department. The most accurate information on fund balance can be found in our CAFR (audit) document which is on our web site. The General Fund is shown on page 22. Major Enterprise Funds (Water, Wastewater and Transit) are found on page 26. Special Revenue Funds are shown on pages 88 through 93. Non-major Enterprise Funds can be found on page 132. Internal Service Funds can be found on page 140.

Since the question here was specific to the asset forfeiture funds, the following fund balance information as of June 30, 2014 is being provided. We have some projections on fund balance expected at June 30, 2015, but the analysis we completed is not detailed enough for us to provide those amounts with any level of certainty at this point in time.

2. Provide details on the Police Department baseline additions (\$1M) in FY 2014-15 (Provided 5/22/15)

Staff Response: Attached is a listing of the items that were proposed to be funded with the baseline adjustment made in FY 2014-15 (See page 5 - Police Department Funding from Baseline Adjustment FY 2014-15).

3. For the Police Department, staffing is down 18 positions from FY 2008-09 to present. Which positions are still missing? (Provided 5/27/15)

Staff Response: Since FY 2008-09, the Police Department has been continuously re-assessing staffing needs and program delivery. The Department has conducted reorganizations to improve the delivery of service and to address the changing needs of staff and the community that make it difficult to concisely track the position eliminations and additions that have occurred. The table below shows the positions within the department in FY 2008-09 compared to FY 2015-16.

5. Provide the status of parking enterprise asset management fund (Provided 5/22/15)

Staff Response: The following chart shows the status of the Parking District Asset Management Fund as of June 30, 2014. We have some projections on fund balance expected at June 30, 2015, but the analysis we completed is not detailed enough for us to provide those amounts with any level of certainty at this point in time.

The proposed budget for FY 2015-16 includes spending \$1.5 million of the unassigned funds.

6. How many homeless veterans do we have here? We have 365 vouchers available for how many in need? (Provided 5/27/15)

Staff Response: There were 400 homeless veterans identified in the 2013 Homeless Count. Currently, the Continuum of Care estimates 217 homeless veterans in Sonoma County, with 81 sheltered and 136 unsheltered. Continuum of Care staff is continuing to review data, so these numbers may be updated when staff shares them with the Board of Supervisors in June.

7. Provide a definition of Affordable Housing. (Provided 5/27/15)

Staff Response: The City of Santa Rosa’s Affordable Housing programs are typically restricted to Extremely Low, Very Low, and Low Income households (30%, 50%, and 80% of Area Median Income). The following examples show the qualifying income limits and maximum rent amounts for a three-person household in a two-bedroom housing unit

at a restricted affordable housing complex in the City of Santa Rosa. The rent amounts are based on 30% of household income, and a deduction is taken from the gross rent amount for tenant-paid utilities.

- 8. Provide talking points regarding street maintenance and the current PCI. What is the annual investment needed to maintain? What are our needs? What are we able to do and what are we not able to do? (Provided 5/27/15)**

Staff Response: To maintain our current PCI of 61 costs \$14 million dollars a year. We are currently spending about \$5 million a year on pavement projects and maintenance. Our current annual additional need is approximately \$9 million a year just to maintain the current PCI of 61.

To get to a PCI of 75, which is the Metropolitan Transportation Commissions regional goal, would cost \$35 million a year for 10 years. From that point forward it would cost \$17 million a year to maintain the 75 PCI.

- 9. Provide the total cost of the Santa Rosa Ave widening project. (Provided 5/27/15)**

Staff Response: The cost for the Santa Rosa Avenue Widening Project roadway improvements, which includes traffic signals, sidewalk, bicycle lanes, travel and turning lanes is \$8.2 M. In addition to the roadway cost, \$2.8 M has been expended on utility improvements for the project.

- 10. Provide the list of duties for the proposed Right of Way Agent position. (Provided 5/22/15)**

Staff Response: See page 7 for Right of Way Needs.

Position: Right of Way Agent – FY 15/16

Justification: Several years ago, the Transportation and Public Works Department (TPW) eliminated the City's Right of Way Agent position. In the intervening years, the workload has been partially picked up by a Civil Engineering Technician in TPW who manages several consultant contracts for this type of work and it has been partially performed by the various Engineers and CE Techs in TPW and Santa Rosa Water (SRW) as well as

by other staff with related expertise. SRW has enough work for this position to be reinstated with a need for someone to oversee the ongoing management of properties and leases and the ongoing needs of the Capital Improvement Engineering teams for assistance with property acquisition, easements and ownership research. A SRW Right-of-Way Agent would provide consistency regarding the day to day management of leases, property negotiations, easement acquisition and management and potential annexations as well as assist with the many one-time needs that occur in property and easement acquisition and disposal negotiations.

Anticipated offset: Reinstating this position will result in reduced need for outside consultant services.

11. Provide a status on the ADA compliance program and the plan for the next five years. (Provided 5/22/15)

Staff Response: Attached are two documents that provide the information requested. The first document (Pages 8-17 - Facility Accessibility Improvements Original List) provides the original list that we are currently working on completing. The second document (Pages 18-21 - ADA 5-yr Plan FY 16 to 20) provides the results of our self-assessment and our plan for the next five year period.

12. As a follow-up to the budget study session, a council Member received an email question as follows: *My husband mentioned that the Rec and Park proposed budget at the recent budget hearing included about \$46K for "libraries". When asked, the director was not specific about target of the funds. Do you think this money might help kickstart the proposed Roseland temporary library at the Roseland Village site?*

You might already know that the Library Commission approved \$90K in their new budget. And we at the SCPublic Library Foundation have pledged \$25k to this end. We are also trying to match that with another \$25k in fundraising.... (Provided 5/27/15)

Staff Response: The funds are for improvements at Rincon Valley, Northwest and the Downtown/Main Santa Rosa libraries. Our facilities staff plan to use the funds to address deferred capital maintenance at the buildings – the list includes exterior and interior painting, parking lot stripe/seal, fire alarm systems, and interior floor coverings to name a few.
