RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide security guard services for various City locations, as previously amended by First, Second, Third, Fourth, and Fifth amendments to add/decrease services and adjust compensation.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the contract for one year with no increase to contract unit prices except a 44% increase to money pickup services, increase services to Luther Burbank Home & Gardens, and increasing compensation.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

SCOPE OF SERVICES

Exhibit B to the Agreement is amended by Exhibit B-4 to this Amendment.

2. COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$71,146 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$291,538.05. The Chief Financial Officer is authorized to pay all proper claims from various Key Charge Numbers."

All other terms of the Agreement shall remain in full force and effect.
