

RESOLUTION NO. RES-2021-023

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING AN AGREEMENT BETWEEN THE CITY OF SANTA ROSA AND THE OAKMONT VILLAGE ASSOCIATION TO PROVIDE CITYBUS DEVIATED FIXED ROUTE BUS SERVICES FOR THE OAKMONT COMMUNITY AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND RELATED DOCUMENTS

WHEREAS, the Oakmont Village Association has contracted with the City of Santa Rosa to provide a deviated, fixed route bus service for the Oakmont Community since 1999; and

WHEREAS, the Oakmont Route 16 bus service provides transportation throughout the Oakmont community and direct transportation between the Oakmont Community and shopping centers in Santa Rosa; and

WHEREAS, the deviated component of this service allows the general public when traveling within Oakmont to have the Route 16 deviate from the regular route to pick them up; and

WHEREAS, the Oakmont Village Association desires to again contract with City to provide deviated, fixed route bus service for the Oakmont Community, effective August 1, 2020, for three years with four optional one-year extensions; and

WHEREAS, the Oakmont Village Association will share equally with the City of Santa Rosa Transit Division the annual cost of operating this service.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa approves the City of Santa Rosa and Oakmont Village Association Agreement to provide deviated fixed route bus service for the Oakmont Community, in substantially the same form as attached hereto as Exhibit A, subject to approval as to form by the City Attorney.

BE IT FURTHER RESOLVED that the Council intends that this approval relate back to August 1, 2020, where the City and OVA continued providing bus service during the COVID-19 pandemic.

BE IT FURTHER RESOLVED that the Council authorizes the City Manager or designee to execute the agreement.
