

RESOLUTION NO. RES-2025-134

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA AUTHORIZING THE DIRECTOR OF TRANSPORTATION AND PUBLIC WORKS TO SUBMIT TRANSIT PROJECT APPLICATIONS AND RELATED DOCUMENTS UNDER SCTCA FUNDING PROGRAM CYCLE 2 AND AUTHORIZING THE CHIEF FINANCIAL OFFICER TO INCREASE APPROPRIATIONS EQUAL TO ANY AWARDED FUNDING

WHEREAS the Sonoma County Transportation and Climate Authorities (SCTCA) released a call for projects for its Cycle 2 Funding Program on June 10, 2025; and

WHEREAS applications to the Cycle 2 Funding Program will be used to program various federal, state, and local funds as well as guide future SCTCA-supported grant applications; and

WHEREAS transit operators are eligible to apply for up to five projects under the Cycle 2 Funding Program; and

WHEREAS, Transit Division staff have identified four projects that are consistent with Council goals and priorities and transit system needs and meet the eligibility criteria for the funding program, including 1) Zero-Emissions Bus Roll-out Plan Implementation, 2) MASCOTS Implementation/SMART Connectivity Services, 3) a Transit Priority Evaluation and Feasibility Study, and 4) a Countywide Mobility Management Program; and

WHEREAS, the Transit Division is additionally eligible to participate in countywide project applications to be submitted by Sonoma County Transit and Petaluma Transit for 1) Countywide Regional Mapping and Wayfinding Program implementation, and 2) Countywide Bus Stop and Hub Improvements.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa authorizes the Director of Transportation and Public Works to submit applications for the identified projects including all required documents and agreements to effectuate funding applications or awards, subject to approval as to form by the City Attorney.
