

RESOLUTION NO. 1207

RESOLUTION OF THE BOARD OF PUBLIC UTILITIES RECOMMENDING THAT THE SANTA ROSA CITY COUNCIL ADOPT AN ORDINANCE AMENDING CERTAIN SECTIONS OF SANTA ROSA CITY CODE TITLE 15 SEWERS

WHEREAS, the City of Santa Rosa Industrial Pretreatment Program, as a requirement of Laguna Treatment Plant NPDES Permit Number CA0022764, continuously develops the source control programs to accommodate changes in regulations, pollutants of concern and industrial/commercial business sectors, which may include revisions to Santa Rosa City Code Title 15 Sewers; and

WHEREAS, to meet requirements of the United States Environmental Protection Agency (US EPA) Industrial Pretreatment Program, a local limits study was completed in April of 2019 for the City of Santa Rosa Industrial Pretreatment Program and approved by the North Coast Regional Water Quality Control Board recommending changes to City Code Title 15 Sewers; and

WHEREAS, findings from the 2018 Pretreatment Compliance Inspection of the City of Santa Rosa Industrial Pretreatment Program require revisions to City Code Title 15 Sewers; and

WHEREAS, the US EPA adopted the Dental Office Point Source Category 40 Code Federal Regulations Part 441 with new requirements and definitions, which requires additional updates to City Code Title 15 Sewers.

NOW, THEREFORE, BE IT RESOLVED that the Board of Public Utilities recommends that the Santa Rosa City Council adopt an ordinance amending certain sections of Santa Rosa City Code Title 15 – Sewers: 15-04.030 Definitions ; 15-06.120 Publication of Users in Significant Non-Compliance; 15-06.200 Appeals; 15-08.050 Wastewater discharge permit classification; 15-08.070 Prohibited discharge standards; 15-08.100 Local Limits; 15-08.210 Hauled Wastewater; 15-08.215 Clean-up and remediation projects; 15-08.340 Wastewater discharge permit contents, 15-08.430; Sampling; 15-08.490 Periodic compliance reports and 15-08.567 Amalgam separators.




