RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING FISCAL YEAR 2025-2026 GRANT AGREEMENTS FOR PUBLIC SERVICES, FAIR HOUSING, AND HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA)

WHEREAS, on April 15, 2025, Council, by Resolution No. RES-2025-052, approved the Fiscal Year 2025-2026 Action Plan (Action Plan) detailing the use of Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Housing for Persons with Aids (HOPWA) funds; and

WHEREAS, the Action Plan identified estimated funding allocations, as the U.S. Department of Housing and Urban Development (HUD) awards were not released until May 14, 2025; and

WHEREAS, up to 15% of Fiscal Year 2025-2026 CDBG funds, or \$201,955, and \$180,000 in local funds will be allocated to homeless services organizations and to the federally-mandated fair housing program; and \$513,120 in HOPWA funds will be allocated to providing housing assistance and related supportive services for low-income persons living with HIV/AIDS and their families; and

WHEREAS, the City has delegated the responsibility for administering its housing programs to the Housing Authority of the City of Santa Rosa (Housing Authority), which is staffed by the Department of Housing and Community Services; and

WHEREAS, the recommended public services, fair housing, and HOPWA funding allocations for Fiscal Year 2025-2026 are as follows:
