

# **Economic Development Strategy**



This session aligns with the Economic **Development Strategy** which emphasizes, "Bolster downtown housing, commercial and retail business" and "support a thriving economy".

# Background

On April 9, 2024 (File #24-0315), City Council requested a future agenda item to discuss the impacts of temporarily closing portions of Fourth Street. A motion was passed 5–1 to approve placement of a discussion item on a future agenda concerning the impacts of temporarily closing portions of Fourth Street.

# Survey

1300 + Residents, 30+ Businesses. 30 Days. Results mixed.



## Challenges and Opportunities

#### Pros

- Community gathering and recreation
- Cultural vibrancy and public use of downtown space
- Enhances overall livability
- Potential to stimulate economic activity

#### Cons

- Logistical challenges with product deliveries and loading zones
- Reduced access for customers
- Limited benefit for businesses not oriented toward food, beverage, or entertainment

#### DAO

"Without these items in place, the proposed "pedestrianization" plan will not yield the desired effect of enhancing and improving the economic vibrancy of the Downtown."

- Support for the concept
- Infrastructure improvements
- Enhanced programming
- Traffic circulation and impacts

**Entertainment Zones** 

Other ways to activate downtown public spaces

California Senate Bill 969 (SB 969) allows cities and counties to establish "entertainment zones" where open containers of alcoholic beverages can be consumed on public streets and sidewalks.



### **Options**

- 1. Continue with 4th Street
- 2. Delay or abandon 4<sup>th</sup> Street
- 3. Pursue a pilot closure elsewhere
- 4. Explore other alternatives
- 5. A combination of the above

\*If the City Council wishes to pursue any street closures staff recommends the following next steps to better evaluate feasibility and impacts:

- Infrastructure Analysis
- Traffic and Parking Study
- Cost/Revenue Analysis
- Scheduling Analysis
