SUBJECT: CONTRACT EXTENSION – VEHICLE IMPOUND SERVICES FOR

EVIDENCE STORAGE

RECOMMENDATION

It is recommended by the Finance and Police Departments that the Council, by resolution, approve the Third Amendment to General Services Agreement (GSA) #F000651 for vehicle impound services related to evidence storage with Yarbrough Bros. Towing, Inc., Santa Rosa, California, to extend the contract for an additional one year term and add funding in the amount of \$40,000 for a total Agreement amount not to exceed \$138,000.

EXECUTIVE SUMMARY

This contract provides vehicle impound services to the City of Santa Rosa Police Department to store impound vehicle that are towed as a result of an accident or crime. These vehicles are evidence and must be stored in a secure, locked facility during the process of investigation.

BACKGROUND

On September 24, 2013, Request for Quote (RFQ) 13-45 solicited by the City, was opened by the Purchasing Agent. On December 3, 2016, the City Purchasing Agent approved GSA #F000651 for vehicle impound services for a two-year term in the amount of \$49,000 with three additional one-year extension options to Yarbrough Bros. Towing, Inc., Santa Rosa, California. The First Amendment extended the contract for an additional year and added funds in the amount of \$24,500, cumulative value not to exceed \$73,500. The Second Amendment extended the contract for an additional year and added funds in the amount of \$24,500, cumulative value not to exceed \$98,000. The contractor provides to the City, all qualified labor, equipment, and transportation necessary to provide vehicle impound services.

PRIOR CITY COUNCIL REVIEW

<u>ANALYSIS</u>

Yarbrough Bros. Inc. has agreed to amend the contract to extend for an additional year with no increase in contract price. This is the final extension authorized for this Agreement.

The City and Yarbrough Bros. Inc. entered into a two-year Agreement with three one-year extension options on December 3, 2013, awarded by the City Purchasing Agent. See contract activity chart below:
